

# ZONING TEXT AMENDMENT NO. 25-001

SMOKE/TOBACCO SHOPS February 11, 2025

### REQUEST

- Zoning Text Amendment (ZTA) No. 25-001:
- Amend four chapters of the HBZSO
- Smoke/Tobacco Shop Regulations
  - Define Smoke/Tobacco Shop
  - Prevent overconcentration of use
  - Reduce exposure to sensitive uses
- Chapter 212 Delete duplicate text



#### **PURPOSE & BACKGROUND**

- Cities and counties have passed additional policies to implement state laws and regulations regarding tobacco retailers
- Many jurisdictions restrict:
  - What retailers may sell
  - Where retailers may be located
  - Counter efforts to attract new (younger) customers
- HBZSO does not identify tobacco retailers (smoke/tobacco shops)
  - Permitted by right
  - City Council directed staff to draft standards to regulate these uses



#### SMOKE/TOBACCO SHOPS

- Section 204.10 Use Classifications
  - Retail Sales amended to include the definition of smoke/tobacco shop
    - Identify use
    - Establish what may be sold under use classification
- Section 211.04 CO, CG, and CV Districts Land Use Controls
  - Land use control table amended to identify where smoke/tobacco shops may be permitted

#### SMOKE/TOBACCO SHOPS CONT.

- Section 230.54 Smoke/Tobacco Shops
  - Added standards to regulate newly defined Smoke/Tobacco Shops
  - Definitions
    - Lists items sold in shops
    - Defines youth-populated area
      - PreK-2 schools; child-care facilities, libraries; parks; youth centers
  - Location:
    - Limited to commercial zones; residential zones prohibited
      - Will continue to be allowed in zones where they are currently allowed
    - 500-foot separation from hospitals and youth-populated areas

#### SMOKE/TOBACCO SHOPS CONT.

- Section 230.54 Smoke/Tobacco Shops
  - Site Standards
    - Signage to prohibit minors
    - Visible window area and interior lighting
    - Smoking prohibited on premise
  - Nonconforming Shops
    - Permitted unless
      - changes use; cannot revert back
      - abandoned or discontinued
         for six months

#### RECOMMENDATION

- Staff recommends approval of Zoning Text Amendment No. 25-001 based on the following:
  - Consistent with General Plan goals and policies.
  - Cleans up the HBZSO to improve clarity;
  - It addresses community need to prevent the proliferation and cluster of smoke/tobacco retailers, especially near youth populated areas
