structure to be constructed over the Shipley Nature Center's

Marco Cuevas Jr., Associate Planner, provided an overview of the proposed project as presented in the Staff Report and outlined staff's recommendation of approval to the Design Review Board.

Board Member Dahl stated concerns with the material and Spanish style, with preference to the bevel. He also stated that the drawings were inconsistent and needed to be more professional. He also noted that the stone should be on all the columns.

Frank Drevdahl, applicant noted that the material came with a lifetime warranty and that new drawings would be done by their cat system.

Board Member Santiago cited concerns with the material because of the location being in a marine environment.

Board Member Thienes commented on concerns with the structural design.

Frank Drevdahl, applicant confirmed that there is a dense material in the post.

John Scandura, president of the Friends of Shipley Nature Center, cited that the amphitheater is a center piece for all outdoor activities, and it helps create revenue when rented out. He noted that they want to shield visitors from the weather and that he is very confident in the material being durable and maintenance free.

Board Member Dahl stated he would like to continue this item, to obtain a precise drawing from the applicant, depicting the actual design of the structure.
