SECTION 3. That said disbursements or withdrawals shall be made only upon the manual or facsimile signatures of Jason Schmitt, Joyce Zacks, Colin Stevens and Zack Zithisakthanakul whose signatures are on file in the Office of the City Clerk. (Exhibit A.)
