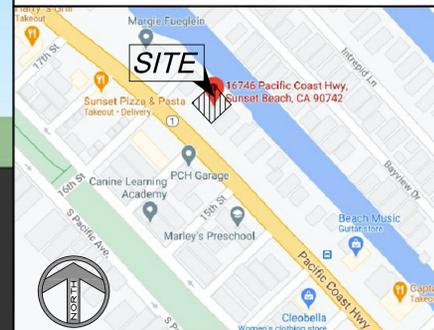

VICINITY MAP



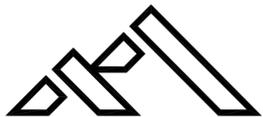

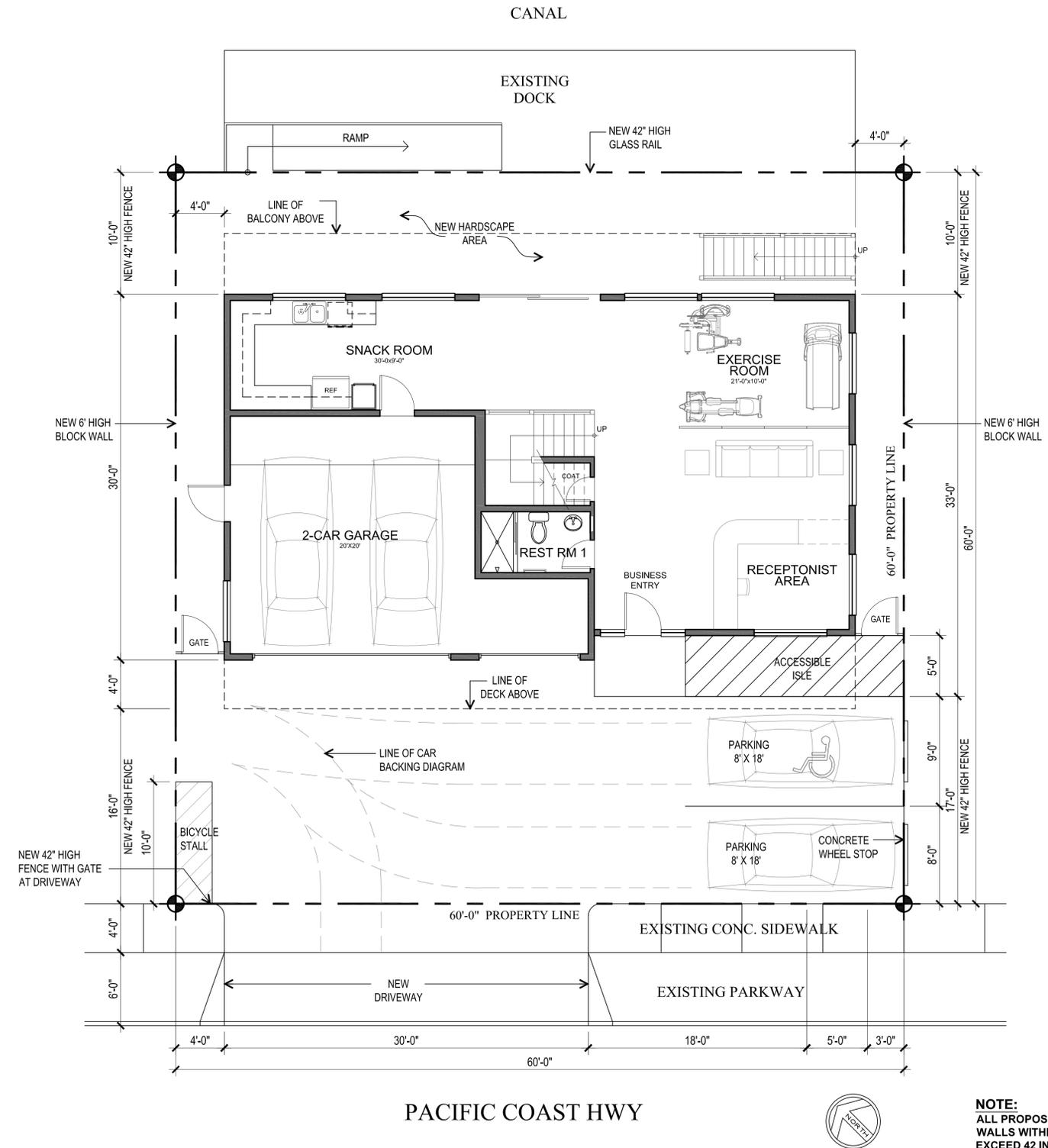

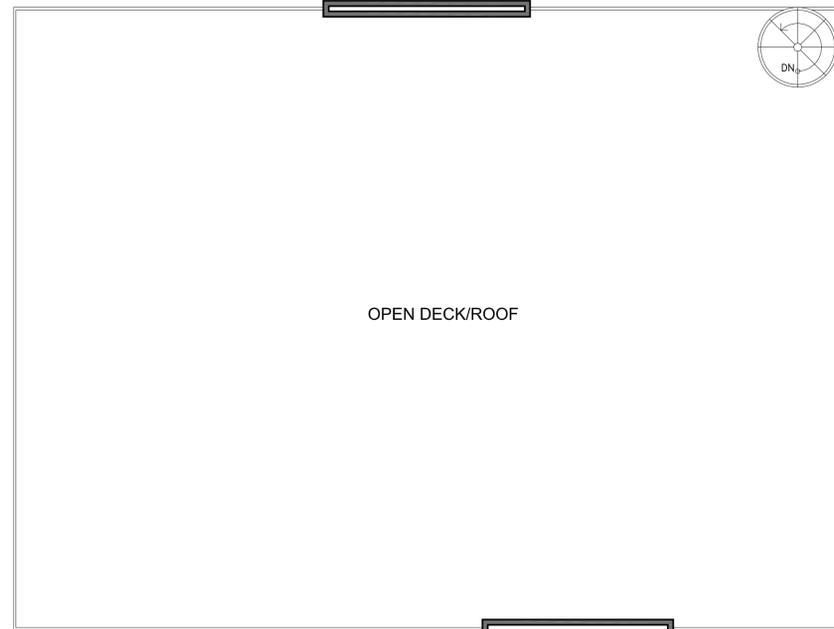

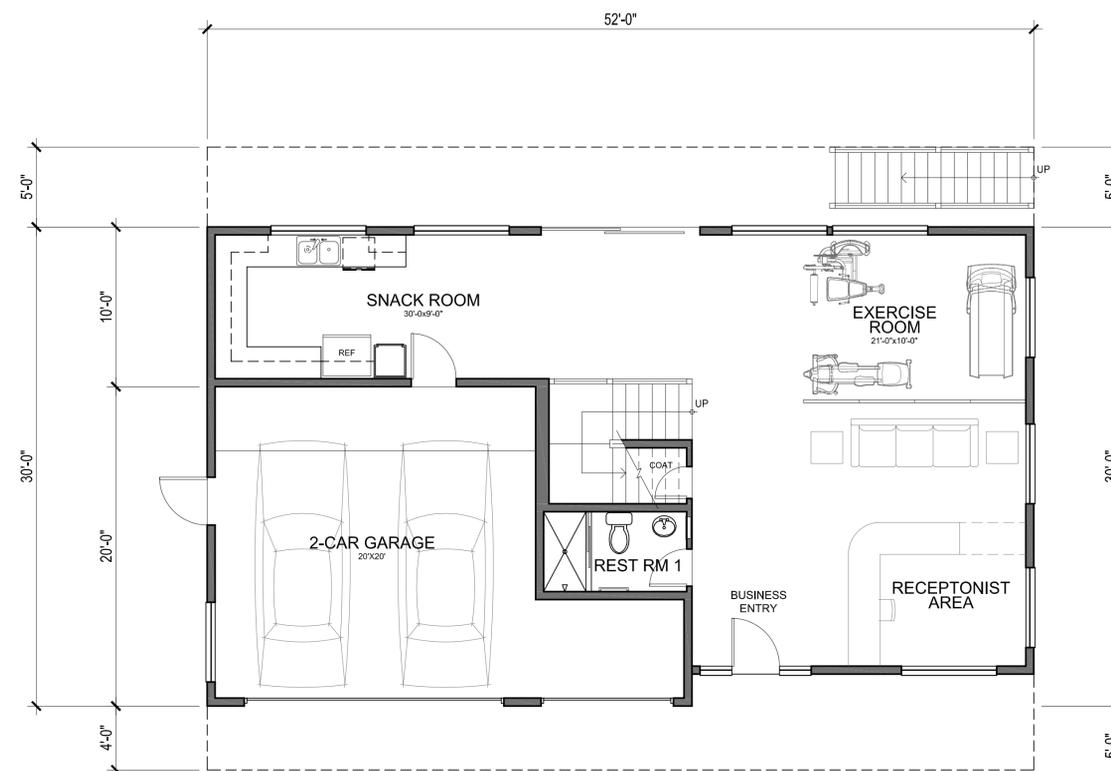
