

PETITION FOR CONDITIONAL LICENSE

WHEREAS, petitioners have filed an application for the issuance of the above-referred to license, for the above-mentioned premises; and,

WHEREAS, issuance of a license without the below described conditions would be contrary to public welfare and morals.

NOW, THEREFORE, the undersigned petitioner(s) do/does hereby petition for a conditional license as follows, to-wit:

01. Alcoholic beverages may be sold, served, or consumed, only within the barricaded area outlined in red that indicated on the attached diagram.
02. The security persons will prevent people from carrying alcoholic beverages outside the designated area as noted in condition #1.
03. Sales, service and consumption of alcoholic beverage shall occur only during the hours of **12:00 pm to 10:00 pm on September 27, 2025.**
04. All persons serving or otherwise dispensing alcoholic beverages must be 21 years old or older

Initial:


05. No more than two (2) alcoholic beverages may be purchased by any one (1) person at any one (1) time.
06. All persons serving alcoholic beverages cannot consume any alcoholic beverages.
07. The petitioner shall sell alcoholic beverages only to persons who have obtained a non-removable bracelet, wristband or stamp identifying the individual as being 21 years of age or older. Reliance solely on said bracelet or wristband will not relieve any person of responsibility should it be determined that he purchase and/or consumer is under 21 years of age.

PETITIONER acknowledges that failure to comply with the foregoing conditions shall be grounds for the summary revocation of the conditional temporary one day permit(s).

PETITIONER stipulates that the Department of Alcoholic Beverage Control and the **Huntington Beach** Police Department may summarily revoke the conditional temporary one day permit should either Department, in their discretion, determine that the public welfare and morals are being impaired and/or a law enforcement problem is being created, and that upon notice of such revocation, petitioner shall immediately surrender the license to either Department and cease all sales and service of alcoholic beverages at the event for which the one day permit was issued.

PETITIONER agrees to retain a copy of the petition on the premises at all times and will be prepared to produce it immediately upon the request of any peace officer.
