#### 24-260 Adopt Fiscal Year 2024/2025 Budget

## 24-261 Engineer's Report

Alvin Papa gave an update on the Cathodic Protection Project. This project will extend the lifetime of the OC-35 30" pipeline by roughly 25-50 years. We will have a better estimate after inspection and design of the cathodic protection system.

Ardurra was hired as the design consultant with a Notice to Proceed date of April 18, 2024. All member agencies will be asked to participate in the design review process at 30%, 75% and Final Design. The original estimate developed for the project 5 years was approximately \$4 million for construction only. It is likely that this price has risen due to construction cost inflation of approximately 38-40% over the past 5 years. Staff will provide an updated cost estimate for discussion once it is ready from the consultant.

To provide potential cost savings, Mr. Papa stated that staff would explore the viability of performing some of the work by in-house staff, if possible. This will be looked at as part of the design process.
