

AMENDMENT NO. 2 TO SERVICE AGREEMENT BETWEEN  
THE CITY OF HUNTINGTON BEACH AND  
UNIVERSAL PROTECTION SERVICE, LP DBA ALLIED  
UNIVERSAL SECURITY SERVICES (AUSS)  
FOR  
STREET SWEEPING ENFORCEMENT SERVICES

THIS AMENDMENT is made and entered into by and between the CITY OF  
HUNTINGTON BEACH, a California municipal corporation, hereinafter referred to  
as "City," and UNIVERSAL PROTECTION SERVICE, LP a California limited partnership  
DBA ALLIED UNIVERSAL SECURITY SERVICES, hereinafter referred to as  
"Consultant."

WHEREAS, City and Consultant are parties to that certain agreement, dated January 1,  
2020, entitled "Service Agreement Between the City of Huntington Beach and Universal  
Protection Service, LP dba Allied Universal Security Services (AUSS)" which agreement  
shall hereinafter be referred to as the "Original Agreement"; and City and Consultant wish to  
amend the Original Agreement to increase the amount of compensation to be paid to  
Consultant,

NOW, THEREFORE, it is agreed by City and Consultant as follows:

1. ADDITIONAL COMPENSATION

In consideration of the services to be performed under the Original  
Agreement, City agrees to pay Consultant at the rates specified in Exhibit B which is  
attached hereto and incorporated by reference into this Agreement. City further agrees to  
pay Consultant an additional sum not to exceed Four Hundred Eleven Thousand Two  
Hundred Sixty Nine Dollars and Forty Five Cents (\$411,269.45). The additional sum  
shall be added to the original sum of One Million Five Hundred Eighteen Thousand Two  
Hundred Seventy Two Dollars and Fourteen Cents (\$1,518,272.14), for a new contract

amount not to exceed One Million Nine Hundred Twenty Nine Thousand Five Hundred Forty One Dollars and Fifty Nine Cents (\$1,929,541.59).

2. TERM

The term of the Agreement is extended for one additional year until December 31, 2024.

3. REAFFIRMATION

Except as specifically modified herein, all other terms and conditions for the Original Agreement shall remain in full force and effect.
