19. 26-105 Approved and Authorized Execution of *amended* Amendment No. 1 to the Professional Services Contract with Sierra Analytic Laboratories, Inc. for Water Quality Analysis and Sampling, to Increase the Not-to-Exceed Amount by \$120,000 and Extend the Contract Term by One Year

Councilmember Kennedy pulled this item to explain for public benefit that this program is mandated by the government, and he believes this action provides a learning opportunity for staff to better understand how to become as efficient as possible with taxpayer dollars. He encouraged staff to consider starting the Request For Proposal (RFP) process at least six months before a contract expires, rather than just extending a contract with the current vendor, to ensure the best vendor at the best price going forward.

Councilmember Williams confirmed this was a three-year contract that expires this month and encouraged setting up a master list of all contracts with a trigger to ensure contracts are open to a competitive bid process in a timely manner, so the process is completed before contract expiration. He encouraged staff to look at additional ways the City could handle water quality analysis and sampling to possibly reduce the costs.

Mayor Pro Tem Twining stated his appreciation for the intent expressed by Councilmembers Kennedy and Williams and agrees there are a lot of companies providing these services and noted the importance of confirming the bidding process includes verification of proper certification.

Mayor McKeon confirmed with Public Works Director Chau Vu that City staff currently is qualified and trained and does take field water samples and deliver them to the lab for analysis.

Councilmember Kennedy clarified that Director Vu is doing a fantastic job and has shown a willingness to look at options for cost savings.

After the amended motion was made, Mayor McKeon confirmed with Director Vu the motion was acceptable.

A motion was made by Kennedy, second Williams to Approve and authorize the Mayor and City Clerk to execute Amendment No. 1 to the Professional Services Contract between the City of Huntington Beach and Sierra Analytic Laboratories, Inc. for Water Quality Analysis and Sampling, increasing the not-to-exceed amount to \$120,000 **60,000** and extending the contract term ~~by one year~~ **up to six months; as amended to ask staff to immediately start the Request for Proposal (RFP) process, including research to identify appropriate vendors and determine if they are interested in participating in the City's RFP process, with the expectation that within 6 months this item will be returned to Council to either approve a vendor or extend this contract.**

Councilmember Kennedy and City Manager Travis Hopkins discussed the history of changes made through the years.

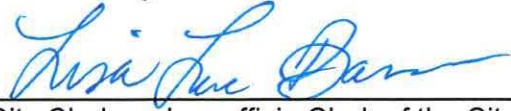
