Hi there,

I am a constituent and a mom who loves our library. I've always been a library lover and the HB libraries, especially Central, are exceptional. Story time is incredible, it's more than just a story being read. If you've never been, there are songs, educational interludes that focus on early math and literacy skills, and then an art project at the end that ties it all together depending on what that week's theme is. I am so proud of our library and it is considered one of the best in OC. Nothing should be done to change that. Libraries are about community and should reflect the community within which it resides and serves. Our current library has over 900 volunteers who joyfully give their time to make our library what it is. If the library becomes run by a for-profit, private company, I fear those numbers will significantly dwindle if not disappear entirely.

I'm also a lawyer and I understand what the current council majority is trying to do. However, I request the city manager, city attorney, and city clerk to prepare resolutions, ordinances, and all materials necessary to place two items for consideration on the November 5, 2024 ballot for the General Election. I also ask the agencies for a vote at the June 4, 2024 City Council meeting these same items. These items are:

1. A Charter Amendment to require a majority vote of the City council and a majority vote of the electors of HB to approve any proposal that would change the wholesale management of the library, and/or any proposal to operate the library with a private contractor that would employ library staff to achieve cost savings; and
2. An advisory vote of the electors of HB on whether to hire a third-party contractor to operate the HBPL; a replacement of the current management structure, as proposed by the City council at its March 19, 2024 meeting. Additionally direct the City Manager to cease any further work on the Request for Proposals as it relates to the action taken at the March 19, 2024 meeting.

Privatizing our libraries will take away so much from HB. It has been shown that libraries run by companies like LS&S only focus on popular titles and get rid of lesser known authors or books. The whole point of the library is that it has everything! If you want the popular books, buy it on Amazon.

I also have concerns for the library staff. While I know there is a law signed in 2011 preventing privatizing library operations from agreeing to contracts that would cause library staff to lose their jobs, wages, benefits, or hours, I have concerns with the history of LS&S, the leader in library privatization. In 2017 the company was penalized almost \$70k for wage and hour violations. It is known to devalue staff and the skills librarians possess. LS&S also shows away from any discourse with the public which is a huge concern for those of us who regularly frequent the library. We want to be heard and we want our opinions to matter.

Individuals who cannot afford fees or a private membership will completely lose access to the

thousands of books in the library, and the growth and knowledge that comes with access. Libraries are a refuge, a place where anyone can go for some peace, or to find community, or to gain enlightenment. Our libraries are so vibrant right now. If the current majority got their way, it would dim the light within a huge portion of our community. Please don't do that to HB.

While the city may save a pittance by going private, the community massively loses out.

I am a long-time resident of Huntington Beach and use the library at Central Park all the time. I encourage my students to read by taking out books for them because their parents don't have the time to take them. So, I truly hope that those of you wanting to privatize this wonderful library are doing everything you can to make sure it will benefit the most people. The library is busy all the time. so it is definitely an asset to our city.

I've done some research on the internet to look at the pros and cons of going private. I read a survey done in Colorado about going private and this is what they came up with. An analysis of the survey comments showed that nearly three-fourths (73%) contained pro-public management sentiments, while close to one-fourth (23%) were either pro-private or discussed alternatives to the black-and-white, public-versus-private debate. For example, several respondents suggested incorporation as a private, nonprofit entity (such as the New York Public Library) or implementation of business practices into libraries' current management structures.

I thought this was interesting about the NY Public Library. Perhaps this is the way to go with our library? There were also some cons to it such as becoming a 501C3. The NY Public library is a private, non-governmental, independently managed, nonprofit corporation operating with both private and public financing.<sup>[6]</sup>

- To register as a nonprofit corporation, the organization typically needs articles of incorporation, by-laws, and an initial group of trustees or officers.
- Once registered as a nonprofit corporation, an organization may become a 501©(3). This is a federal tax status granted by the IRS. It allows donations to the charitable business to be tax-deductible for donors.
- 
- The process to become a 501©(3) can be cumbersome and time-consuming, often requiring legal assistance.
- 
- [Public libraries that are government agencies can receive donations, and these donations are tax-deductible for donors without needing 501©\(3\) status](#)<sup>1</sup>.

I watched a city council meeting on the television and heard our mayor say she had found some almost pornographic books in the middle school section. That really surprised me so was discussing that with several mothers who are very involved in their churches so want their kids to be raised in a faith based family. I was shocked when they said that most kids look up stuff worse than that on the internet, so it shouldn't be that big of a deal if it is in the library!

I'm also surprised that the librarians would consider these healthy for that age. Have the members who want this change in how the library is run, interviewed the librarians and asked what their views are of these types of books? Perhaps they were bought many years ago and haven't been considered for their content in today's world. Any mention of censorship immediately creates havoc in our divided world.

I think it would be more democratic to allow Agenda item 24-350 be passed and then the choice be on the ballot in November to let the citizens decide.

If a parent wants to check out one of these books for their child it's their right, but it should be the parent's discretion and NOT the librarians.


