The results are in favor of Huntington Central  
Library. 44 against the implementation of a  
Parent/Guardian Review Board, & 10 in favor;  
66 were against the Privatization RFP process,  
while 5 were in favor; 2 comments were  
undecided or opinion was unclear. This

Vote:

Surely **millions** of HB residents have long been dependent on their groundbreaking research at Central Library. Selling libraries to library companies is an **absolute stupid** idea from totalitarian developers; at such an important time for research, this is tyranny. 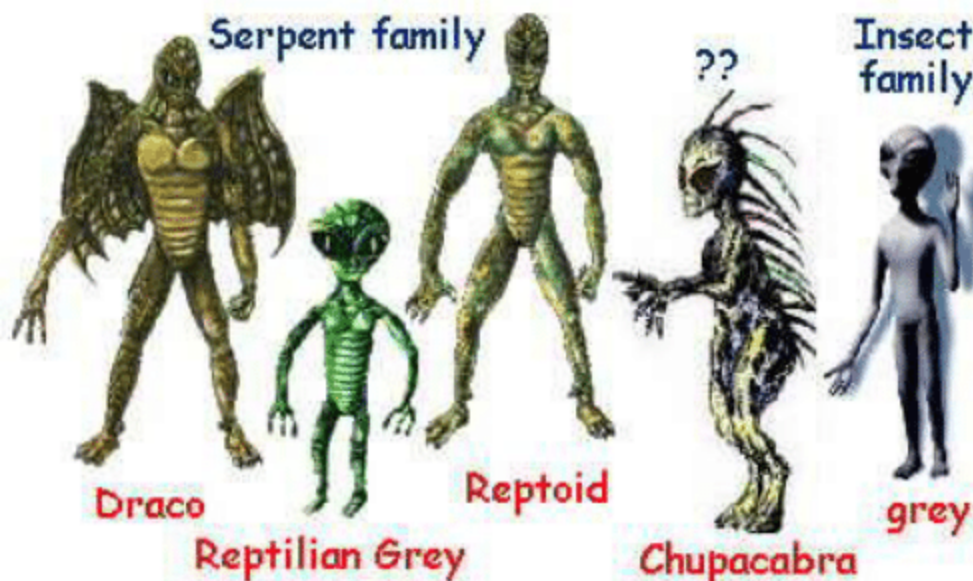
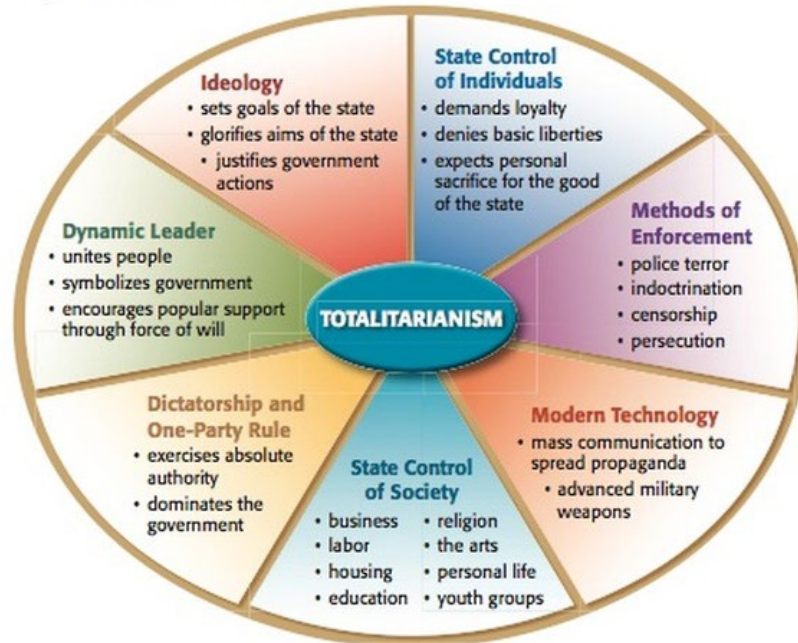


# Totalitarianism
