A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF HUNTINGTON BEACH AUTHORIZING THE MANUAL AND/OR
FACSIMILE SIGNATURES OF THE CHIEF FINANCIAL OFFICER, CITY TREASURER,
ASSISTANT CHIEF FINANCIAL OFFICER, AND FINANCE MANAGER-TREASURY AS
PERSONS AUTHORIZED TO EXECUTE FINANCIAL TRANSACTIONS IN THE NAME
OF THE CITY OF HUNTINGTON BEACH

The City Council of the City of Huntington Beach does hereby resolve as follows:

SECTION 1. That Dahle Bulosan, Alisa Backstrom, Sunny Rief, and Joyce Zacks are designated as the persons authorized to execute financial transactions in the name of the City of Huntington Beach.

SECTION 2, That Dahle Bulosan, Alisa Backstrom, Sunny Rief, and Joyce Zacks are designated as the persons authorized to execute all checks, drafts, warrants or other orders for the payment of money drawn in the name of the City of Huntington Beach on deposit with any bank or other financial institutions in which the City has funds. At least two (2) authorized signatures must appear on each such disbursement or withdrawal.

SECTION 3. That said disbursements or withdrawals shall be made only upon the manual or facsimile signatures of Dahle Bulosan, Alisa Backstrom, Sunny Rief, and Joyce Zacks whose signatures are on file in the Office of the City Clerk. (Exhibit A.)

SECTION 4. All Resolutions in conflict herewith are hereby repealed.




