1. 24-644 Approve and Adopt Minutes of the August 14, 2024 Meeting

2. 24-645 Approval of Pickleball Rules at Edison Park

Staff provided information on the community feedback survey and proposed rules. Discussion ensued on the rules and various types of play between singles, doubles, the movement of the line queues, and paddle system. Staff said they worked with the current contract instructor for general rules used at most courts. Edison will implement the rules as designed based on community input, while Worthy will utilize a different paddle system. Discussion continued with various types of play and the issues that the new rules should mitigate.
