#### City Staff Updates

Staff Liaison Molly Uemura provides an update on the event contractor. The contract was pulled on February 20<sup>th</sup>, but will be brought back to council for approval on the March 19<sup>th</sup> meeting. Uemura suggests that the Board call a special meeting immediately following council approval to meet the contractors and hit the ground running. Staff understands that the event is getting a late start and that deadlines are quickly approaching.

Uemura has secured the fireworks vendor and the fireworks contract will be put through the City Attorney's Office shortly. The Office of Communications is also working on integrating the parade application to the new City website.

Uemura suggests that the Board call a special meeting for the week of council approval. Board members agree that March 21<sup>st</sup> would work for a special meeting.

### **Board Member Reports**

Moreo requests permission to move forward with planning the home decorating contest as we await the new Contractor. Staff advises that the contractor is supportive of this activation and other cost-neutral activations.
