The City Council further desires to amend the Community Services Department charges for parking lots as identified in Exhibit A to this Resolution; and

The City of Huntington Beach adopts the Fees and Charges in the Recommended Fee Level column attached in Exhibit A, which shall become effective following the adoption of this Resolution, and continue thereafter.


