As a 45-year resident of HB, I have comments on several of the agenda items on the February 7 agenda:

Item 11 — I don't support the idea of allowing more money in politics, particularly from out of the City. This increase will allow special interests to have even more influence on our City affairs. A broader contribution base of relatively small donors would be much more representative of our community. Please do not approve this increase.

Item 12 — Requiring in-person complaints will discourage people who have the most visibility into code violations from pointing them out. For example, restaurant workers who observe dangerous health code violations may be hesitant to report them for fear of losing their jobs. Also, neighbors who observe violation of building codes may not report them for fear of retribution. This proposal sounds like a very bad idea.

Item 30 — I support this one. We should not be flying special interest flags, which we may not all agree with, on city flag poles. POW/MIA flags should be OK and non-controversial, but all others should not be allowed.

Item 31 — Although I do not support the State housing regulations being challenged, spending more City money to challenge them seems like a waste of taxpayer money and staff time. The current City Attorney has not had a record of success with these challenges, and there is no reason to believe the same City Attorney will do any better in the future. We should accept the fact that these regulations exist, and try to find a way to comply with them in an absolutely minimal way. Money could be more productively spent by exploring how we could best comply with the letter (if not the spirit) of the rules.

Item 32 — Given that the COVID threat is much reduced (especially for people who get the available boosters), I see no reason to reverse the Mayor's decree.

Dear Mayor Strickland and City Council Members,

As leaders and public servants, I know that you all take your roles very seriously, and I thank you for your dedication and service to our community. As a native of Huntington Beach, an alumni of Edison and parents to two Edison High students, I have long held Huntington Beach and its beautiful culture close to my heart.

We all know that times are rapidly changing and there are many divisive issues facing our city, nation, and even our world, I know we all agree, though, that we want to make our city as wonderful as possible.

A few years ago, when I first saw the pride flag waving at the HB Pier, I honestly felt dismayed. The beach should be a place for recreation and relaxation--not a place for political statements. I don't believe that displaying the pride flag makes our beach safer for anyone. People of all creeds, colors, and orientations can access our beaches safely. We do not need what feels like virtue signaling and political grandstanding at our beach. There are no policies or practices at our beaches which are discriminatory. I challenge you to name one.

Last summer during Jr. Guards, my ten year old son was told by another child, who pointed to the flag, about how the flag represented gay marriage and gay equality. This led to a conversation about sexual orientation, sexual positions, details about how gay people have sex, and other sexual issues that my son was not ready for. My son shared this with me when he came home, and we talked about it, but I wish he had not had such early exposure to that information. I believe that this topic never would have come up had the flag not been there. Exposing children to sexual topics is a form of grooming and should not be happening.

While we all love the idea of inclusion, love, and harmony, no one can deny that the rainbow flag primarily connotes concepts of sexuality and sexual identity, despite the brown and black stripes which were added recently. I don't know any straight people of color who identify with the rainbow flag, yet it seems primarily to be a banner of pride in the LGBTQ community. Topics of sexual preference and identity are not appropriate to emphasize at a public beach, particularly one that focuses on hosting children's events.

Dear Council Members,

I disagree with the movement to stop flying the PRIDE flag in June. The LGBTQ+ community is part of every community, including Huntington Beach and the PRIDE flag is a symbol of unity and acceptance.

Huntington Beach already has an infamous reputation outside of Orange County as an enclave for regressive bigoted people and behavior. By entertaining the motion to cease flying the pride flag - something that nearly every other country, city and corporation does in the month of June - you are verifying that negative perception of Huntington Beach as a hateful place to live.

I understand that the rationale for not flying the flag is to avoid being divisive, but it is the year 2023. It costs you next to nothing to fly this flag. To rescind this infinitesimal symbolic gesture of tolerance sends a very dangerous and damaging message to the LGBTQ+ folks who live here. It validates the ridicule and scrutiny that many LGBTQ+ kids face growing up in this city. It says, "I don't care about you faggots enough to even fly this piece of fabric with six colors on it." Is that the kind of message that we want to send not only to our city, but to the rest of the world?

Hello City Council,

My name is Mark Rosenberg and I have been a resident of Huntington Beach for about 8 years now. I chose to move to this city because of its natural beauty and the acceptance and open mindedness that seemed to be growing in town. This is why I am emailing you today.

I feel it is vital to continue flying the rainbow pride flag. I feel this way, as a Jewish person, a n ally, and someone with multiple family members who identify as lgbtq.

I know what it's like to been targeted as someone that does not fit. I grew up on a town in Connecticut that, while it was relatively accepting, was not remotely diverse and had VERY few Jewish people. I suffered from attacks, verbal and occasionally physical, just because I was different. This was in a climate where it is widely (at least publicly) shunned to be antisemitic (the good old days...). As for my lgbtq friends and family, they did not have that part. There is no common understanding that picking on someone for being lgbtq is wrong. In fact, this group is targeted by countless folks, from religious groups to politicians and legislators. This why a public show of support for this group is vital. The targeting of young lgbtq children has had devastating effects on the safety (emotional and physical) of these children, and if even only one child sees that flag and feels included, it is well worth it.

Now let's move to the obvious: it's already been up. To remove the flag now would boldly suggest that the city of Huntington Beach, via a city council without a supermajority, does not support and welcome these folks (children included). Now you might argue that flying it in the first place is unequal treatment. "What about other groups?" I would argue that that is a moot point as again, the flag has already been flying, so the only statement you can make now is either keep it up as is, or take it down and set a precedent that the city does not show that support. It's been mere months since the massacre in Colorado Springs, only years since pulse. This is no time to be playing around with this narrative.

Additionally, I might ask, who does this flag harm? Does it intimidate people? It certainly doesn't suggest anything other than acceptance and unity. I have love believed that the only real opposition to lgbtq rights and support is religious groups and there is no shortage of legal precedent to show that those religious groups and their beliefs have no place among legislative sessions. Our constitution very clearly states the founders' intentions (especially Jefferson) to keep particular religious beliefs out of our legislation in order to protect the religious freedoms and all other freedoms of all Americans.

So for these reasons and out of the decency of your hearts, I beg of you to take the Hebrew saying to heart, tikkun olam which is to make the world a better place. Make the world a more accepting place and protect the vulnerable. Please keep that flag flying for our friends and family that need to see it today, tomorrow, and in the future.

I am writing to express opposition to Limiting Flag Displays and support to continue flying the Pridé flag for merely 6 weeks and during Pride month.

The Pride Flag shows an expression by our city of <u>inclusion</u> and <u>safety</u> for its residents and visitors. It is a fitting sign of support, respect and recognition for those, who because of their sexual identities, have faced unfair and hurtful discrimination, ridicule and ostracism. Flying the rainbow flag is a reinforcing sign of a community's humanity toward one and all. It represents human dignity and equality for all people.

Continuing to fly the Pride flag and respect for other commemorations is appropriate as a way to raise public awareness, show support and reflect a community's moral and social compass. Flying the Pride flag is a beacon for members of the local LGBTQ community to let them know Huntington Beach recognizes and values them and is committed to protecting their rights and safety.

This is of particular importance to the young people of Huntington Beach who identify as LGBTQ+. A temporary symbol during the month of recognition should be celebrated as helping our youth feel safe, supported and acknowledged by their city. If Huntington Beach is truly concerned about its students and its youth, the Council should vote in support of flying this flag that symbolizes inclusion. As young may know, disproportionate rates of bullying, harassment and mental health issues continue to plague LGBTQ+ youth and voting to end that symbolic support will be a blow to that affected population of our city.

A survey by The Trevor Project, an LGBTQ youth suicide prevention and crisis intervention organization, found that 42 percent of the nearly 35,000 LGBTQ youths who were surveyed seriously considered suicide within the last year. More than half of transgender and nonbinary youths who were surveyed seriously considered suicide, it also found.

A separate survey conducted by The Trevor Project found that LGBTQ youth who reported having at least one LGBTQ-affirming space also reported lower rates of attempting suicide. Huntington Beach should be that affirming space.

The argument about "if we fly this flag, we have to fly all flags requested" is a cop out. Settled law establishes that city governments are free to fly, or not fly, flags on city property as long as it's clear that the city is expressing itself rather than opening up a public forum. City leaders who want to express support for the LGBTQ community should raise the Pride flag without fearing that they'll have no control over which flag is raised next. Show some backbone and support those members in our community by recognizing that love is love, everyone is valued, and our city is a modern one. Let's not go backwards. Voting to remove the flag during Pride month will be a slap in the face to important members of this community.

Does this Council want to be known to our youth, our community and our tourists as the city that went backwards and banned the Pride flag? That is going to be some bad press and will likely make national news.

I can see the headlines now: "New Surf City Council brings *wave* of backwards policies, a slap in the face to LGBTQ+ residents and tourists"

What do we want the world to know – Is Huntington Beach an inclusive, modern, innovative city - or an archaic, divisive, prejudiced city?

This decision WILL make headlines.

I am writing this letter to request that you keep raising the Rainbow Flag this June, as you did over the past few years. As a member of the LGBTQ community, it is important for me to express how important this small, symbolic gesture is. Seeing the flag raised over institutions such as city hall makes me feel safe. I'm 41 years old, and spent my youth in the closet, fearing the repercussions of coming out. Back in the '90s, there was little representation for gay guys like me, and little hope that we can live a joyful life. Thankfully, we've progressed quite a bit since then - but kids today still deal with homophobia, prejudice and unaccepting families. For them, seeing that flag raised high brings light, hope, and a feeling of acceptance that is incomprehensible for someone who hasn't walked a mile in their shoes. It makes them feel that the future could be bright. I know. I've been there. Even for me - now a father of two, together with my husband, and a professor at UCI - seeing the flag raised high brings comfort, confidence and reassurance. To my elementary-school-aged kids, it projects acceptance of their family and pride in who we are. It's quite remarkable how such a small symbol can give hope and reassurance to so many, including many transparent communities such as LGBTQ youth that are experiencing hardships and challenges on a daily basis. You have the power to continue sending this message of confidence and reassurance. Please don't abuse that power. Please make HB safe for the the LGBTQ community members by raising the flag again this June.

I have been a resident and homeowner in Huntington Beach for 48 years and maintained a law office in Huntington Beach for 40 years until my retirement. I have followed the work of the City Council for many years. I have serious concerns about several items on the February 7, 2023 agenda. I urge your careful consideration and measured approach in moving forward with these proposals. Of greatest concern to me are the following:

Item 11, An ordinance raising political campaign contribution limits beyond the inflation standards previously established will result in an unfortunate scenario in which only candidates with wealthy and corporate supporters can possibly be elected. This is a recipe for council corruption and the elimination of diversity on the city's governing body. I urge you to vote NO on enactment of this ordinance.

Item 12, An ordinance prohibiting anonymous reports against businesses and requiring identification and public disclosure of reporters, will be intimidating to the public and have a chilling effect on legitimate reports regarding potentially dangerous Code violations. The public should not be made to fear retaliation or retribution for reporting dangerous conditions or be required to submit to public disclosure of their identity and address. The City Code Enforcement employees can quickly determine whether reports are valid or frivolous. The ordinance language makes an upfront assumption that all reports are wrongful. The opposite should be true. Code enforcement practices should best serve the residents, employees and customers, not make them targets and endanger the safety of reporters and their families. A member of the public providing information for investigation by a city agency is not the official "accuser" as the term is used in criminal prosecution. The City itself would be the complainant in a Code Enforcement action and would be charged with making its own investigation. The reporting person is not even an official witness, only a reporter. Only if the City itself finds a violation of a Code would any action be taken against a business. The ordinance as written will only have the effect of discouraging legitimate reports. I urge you to vote NO on enactment of this ordinance.

Item 30, A proposal by Councilmember Burns to allow only government and POW/MIA flags to be flown at City buildings is obviously targeted at the Pride flag allowed for a few weeks of the year. The council action allowing the flying of the Pride flag was a small act, intended to show compassion and demonstrate that Huntington Beach is a welcoming safe place for all. The flag was perceived by most residents as a minor unthreatening symbol of acceptance. An ordinance disallowing the Pride flag, however, would have far more

significance than the action authorizing the flag, as it sends a clear message of rejection and discrimination. Whatever your feelings about the Pride movement, this ordinance will result in the City being publicly branded as discriminatory and unwelcoming. I urge you to reject this proposed ordinance.

Item 31, Authorizing the City attorney to take all actions necessary to challenge the requirements of AB9 and SB 10, will most certainly result in unnecessary significant cost to the city. Huntington Beach does not exist in a vacuum. Like it or not, we are part of the State of California and subject to its housing laws. Most of the council members have had little education, to date, regarding how and why housing mandates exist. We have already paid millions of dollars to fines that could have gone to good use in our city for defying housing statutes. Continued defiance will not be productive or in the best interests of the residents of Huntington Beach. The argument that more housing in Huntington Beach is incorrect and uninformed. We have had an increase in our city's population and there is almost no housing availability for workers needed in the city, or anyone earning less than \$100,000 per year. The existing population has also created the need for housing for households it created. The children who grew up in your homes become adults needing their own homes, adding to the number of household dwellings required. You want your children and grandchildren to remain here in Huntington Beach so they will need housing. Allowing for Duplexes, Accessory Dwelling Units and subdivision of residential lots is the least impactful way to increase available housing without drastically changing the character of our neighborhoods. If you do not want to allow high density residential construction, you need to at least accept the minor impacts of the new state legislation. I urge your rejection of this item.

Item 32, Restoring remote public participation in City Council meetings is essential to allow the public the opportunity to address the council, other than in person or in writing. Many residents, including me, are unable to address the council in person, for numerous reasons. In my case, I care for my 99 year old mother and cannot expose myself to any viruses that may be present in the council chamber. Other residents have transportation, employment, disability and child/elder care responsibilities that make in person appearances impossible. You have all championed expansion of the public's right to speak at council meetings. I urge you to support restoration of remote participation.

I hope the City Council will fully deliberate and consider the need for, effects and ramifications of the above proposals, with the focus on serving the best interests of the City and its residents.

#### A NO vote on Item 11:

This item refers to a final vote to increase the limit of campaign contributions from an individual. The current limit of \$620 per individual would be increased to \$5500 per individual, which would represent a significant increase. An increase in campaign contribution limits can be seen as unfair to poor citizens because it gives more power and influence to those who have more money. When individuals with financial resources can make larger campaign contributions, they have the potential to shape election outcomes and have their voices heard more loudly than those without similar financial resources. This can lead to a situation where the concerns and interests of the wealthy are prioritized over those of the less fortunate, creating an imbalance of power in the political system. For this reason, an increase in campaign contribution limits can be seen as a threat to the principle of political equality, as it gives more weight to the opinions of the wealthy, and less weight to the opinions of the less fortunate.

#### A No vote on Item 12:

Banning anonymous code enforcement reports could violate the First Amendment right to free speech and discourage individuals from reporting code violations out of fear of retaliation. The measure also carries a significant risk of litigation, including a lawsuit from the ACLU, which would result in significant legal costs and resources for the organization.

Instead of a ban on anonymous reporting, it may be more effective to consider alternative solutions that preserve the benefits of anonymous reporting, such as implementing robust whistleblower protection policies.

# A NO vote on Item 30:

Banning commemorative flags on city flag poles goes against the principles of diversity and inclusivity that our city prides itself on. The Pride flag, which was the reason for the introduction of this ordinance, symbolizes the struggles and victories of the LGBTQ+ community and is a symbol of hope and acceptance. By banning it from being flown on city flag poles, we send a message of exclusion and disregard for the rights of marginalized groups. Instead of suppressing the display of certain flags, we should embrace the rich tapestry of identities and perspectives represented in our city.

#### A YES vote on Item 32:

Item 32 is a commendable proposal that aims to make council meetings more accessible to a wider range of citizens. The practice of remote access via Zoom, which was discontinued recently, has proven to be beneficial in increasing civic participation during the pandemic. It has provided an opportunity for those who are unable to physically attend public

meetings, as well as those with busy schedules, to take part in important discussions and decision-making processes. By resuming this practice, the city council would demonstrate its commitment to promoting transparency, inclusivity, and participation in the democratic process. Overall, I strongly support Item 32 and believe it will have a positive impact on the community.

Tonight, I ask you to read the Declaration of Policy About Human Dignity, unanimously adopted by the Huntington Beach City Council on May 6, 1996. In this policy, they stated:

"that everyone should be treated with courtesy and respect, regardless of their racial background," their nation of origin, the religion they practice, their sexual orientation, gender or disability status. It is the right of all citizens to pursue their daily lives with the knowledge that they will not be physically harmed or verbally abused.... ... Remember that silence and apathy are the greatest allies of those committing hate crime."

That elected City Council in 1996, like you, were elected to serve as non-partisan representatives for our city. They, like you, were elected to represent \*ALL\* the people in the Huntington Beach community.

Tonight, there is an agenda item concerning ending flying the LGBTQ Flag during June, PRIDE month. As a City committed to treating everyone with courtesy and respect, it is your responsibility to stand against bigotry and those committing hate. How does this relate to the PRIDE Flag? The PRIDE Flag, like the MIA/POW Flag is a flag that represents ALL Americans. There are LGBTQ+ Americans in every political party, in every race, every gender, every culture, every religion, every economic background and in every neighborhood in Huntington Beach. Both the POW/MIA and PRIDE Flag are unifying flags that are flown to represent these groups, and that they are seen and are represented in our city. They are one of only a handful of flags that are meant to unify. And I ask. isn't now a time to unify rather than divide? Do not try and make this a partisan issue, nor a cultural war. Flying the PRIDE flag is critical in supporting inclusive values for several reasons; it is still legal to fire an individual for identifying as LGBTQ in 26 U.S. states, hate crimes against the LGBTQ community are on the rise, LGBTQ youth disproportionately make up 40% of our nation's homeless youth, harmful transgender laws are being passed around the country that our youth are seeing. Removing the PRIDE Flag tells every LGBTQ+ person that Huntington Beach no longer sees them, includes them as someone to protect. LGBTQ+ youth will see this as their City no longer accepting them, they will see them as "less than" in the eyes of this Council. The risk of causing an LGBTQ+ youth in Huntington Beach to commit suicide, or the risk of people in Huntington Beach seeing City Council as approving bigotry behaviors and embolden them into harming LGBTQ+ people is reprehensible.

I am writing this letter to request that you keep raising the Rainbow Flag this June, as you did over the past few years. As a member of the LGBTQ community, it is important for me to express how important this small, symbolic gesture is. Seeing the flag raised over institutions such as city hall makes me feel safe. I'm 41 years old, and spent my youth in the closet, fearing the repercussions of coming out. Back in the '90s, there was little representation for gay guys like me, and little hope that we can live a joyful life. Thankfully, we've progressed quite a bit since then - but kids today still deal with homophobia, prejudice and unaccepting families. For them, seeing that flag raised high brings light, hope, and a feeling of acceptance that is incomprehensible for someone who hasn't walked a mile in their shoes. It makes them feel that the future could be bright. I know. I've been there. Even for me - now a father of two, together with my husband, and a professor at UCI - seeing the flag raised high brings comfort, confidence and reassurance. To my elementary-school-aged kids, it projects acceptance of their family and pride in who we are. It's quite remarkable how such a small symbol can give hope and reassurance to so many, including many transparent communities such as LGBTQ youth that are experiencing hardships and challenges on a daily basis. You have the power to continue sending this message of confidence and reassurance. Please don't abuse that power. Please make HB safe for the the LGBTQ community members by raising the flag again this June.

I wish to express my opposition to agenda item #30. If Mr. Burns' ordinance is adopted, it should apply to any non-government entity flags, including POW/MIA. Mr. Burns cannot single out one private organization for an exception, while others are prohibited. In fact, this exception exposes Mr. Burns' true objective, which is to ban the display of the Pride flag on City property.

Mr. Burn's rationale, is "the City of Huntington Beach should avoid actions that could easily or mistakenly be perceived as divisive". However, if the City does take this action, it most definitely WILL be perceived as divisive, and our community will be known for intolerance. This proposed ordinance would prohibit the flying of the multicolor Pride flag in June, which we have done for the past several years. Mr. Burns' ordinance will backfire, and get our City a lot of attention, and not the kind of attention that he wants.
