I am a retired physician (Ob/Gyn) who has been living in Huntington Beach since 1996. I am also gay. When I was discovering my sexual orientation when I was young, there were no resources available to me to help me navigate through this coming out process. I was too afraid to talk to anyone about it, especially my parents. How reassuring it would have been to go to the library and read about other people experiencing the same issues I was facing alone. That is what libraries are for - getting information, researching ideas, finding yourself in other peoples' experiences by reading fiction written by people who have suffered through the process and want to make it easier for others. By forcing minors to ask adults to take books out of the library for them, you are thwarting one of the a major reasons books are in the library - the ability to explore whatever you want on your own, even for minors. Especially now, when the suicide rate for LGBTQ-trans minors is skyrocketing.

Another point, reading books in libraries does not make teens more sexually active. Not having reproductive health education is what has been shown to lead to increases in teen pregnancy and sexually transmitted infections, not reading fiction. People who really care about children will make sure that accurate sex education is available to them. With girls as young as 12, 13 getting pregnant, waiting until they are 14 or older for accurate sex education is too late.

We are writing to express our deep concern about Item 18 on your June 20, 2023 agenda, which would direct the City Manager to work with the City Attorney to make obscene and/or pornographic materials unavailable to minors and present new protocols for screening materials for the city's libraries. Given that stringent federal laws are already in place governing the accessibility of such materials to minors, it is difficult to understand what the purpose of this agenda item would be and what the council seeks to achieve with its proposed ordinance. Are there specific instances of violations of federal standards in HB libraries? Existing law would call for criminal prosecution if that is the case. The ancillary proposal to sever ties with the American Library Association is a peculiar, unexplained directive. The ALA—with roughly 50,000 members—has applied our country's library standards since its founding in 1876. Surely its members have more robust background, training and experience—and considerably more time—to distinguish what constitutes obscene and pornographic material than does the City Attorney. To propose otherwise is an overreach of the power you have been afforded by your community. Adoption of agenda item 18 would be a divisive, unproductive use of our local resources. Any attempt to ban books protected by federal law or control our public library is an assault on our community and our democracy.

As elected officials, you likely feel pressure to take action to solve problems that improve our community. As unique individuals, you probably have strong opinions on many of the divisive issues playing out across the country. But at a time when political polarization is feeding on itself, our hope is that you can resist the pressure to enter the political fray. As you know better than most citizens of HB, our city is strongest when our elected leaders collaborate and compromise to solve problems and provide services. Injecting the partisan divide into local decisions is sure to degrade the crucial relationships and trust you need to solve local issues.

As residents of this community since 1997, we ask you to be vigilant in protecting the rights of all of your constituents and ensure that we create a community in keeping with the "OneHB" outlined in the city's strategic plan. The time and the resources you have at your disposal have come from all of your community members, not just some. Council Members,

Sadly, it is once again necessary for Huntington Beach to denounce hatred after headline-grabbing incidents in the city, this time involving destruction of a Pride flag on private property and dissemination of homophobic and antisemitic literature in one of our neighborhoods.

Earlier this year, this City Council was reminded that the Pride flag was originally displayed at City Hall in June, 2021, after a "White Lives Matter" demonstration ended in violence in April of that year. It was a signal that everyone was welcome in Huntington Beach, and that hate would not be tolerated.

This Council then voted 4-3 for an ordinance that now blocks that flag from being flown at City Hall.

Earlier this year, this City Council was also reminded that the Interfaith Council was originally created in response to racist and antisemitic incidents in Huntington Beach, and then asked to provide invocations before Council meetings in response to still more hateful incidents in the city. The Interfaith Council is a powerful symbol and outstanding organization.

This Council then voted 4-3 to "fire" the Interfaith Council as providers of invocations before Council meetings.

Either of those 4-3 votes could have been accompanied by this statement. In fact, minority members of the Council suggested it at the time. It was clearly a choice not to send this message at that time, which was a message of its own.

It is now past time to set this right, and to put the City Council on the right side of a fight that has gone on for too long in Huntington Beach.

It is also time for city leaders to reexamine the exclusionary populism that can fire up a crowd of supporters but also send a dog-whistle to violent outside groups.
