## Community Development Block Grant

### INFORMATION AVAILABLE:

The City of Huntington Beach (City) anticipates receiving Community Development Block Grant (CDBG) program funds from the United States Department of Housing and Urban Development for qualifying projects and programs during the 2025-26 Fiscal Year. It is suggested that applicants review the Application Handbook posted online to ensure that all submissions are eligible, complete, and provided with the appropriate documentation: [www.huntingtonbeachca.gov/CDBG](http://www.huntingtonbeachca.gov/CDBG). Applications are available for any non-profit organization interested in requesting funding. Any eligible non-profit group may be submitted for consideration.

Application packets will be available beginning Thursday, October 3, 2024, on the City's website at: [www.huntingtonbeachca.gov/CDBG](http://www.huntingtonbeachca.gov/CDBG). All applications must be received by 5:00 p.m. on Thursday, December 12, 2024. No late applications will be accepted.

The City of Huntington Beach is developing a new "Consolidated Plan" to shape our community's future from July 2025 to June 2030. This plan will help us decide how to use federal funds, such as CDBG and HOME Investment Partnerships Act (HOME) funds for things like housing, infrastructure, public facilities, economic development, and community services.
