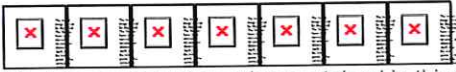

To the Four New Members of Huntington Beach City Council,

As a 20 year resident of Huntington Beach, I am writing to express my opposition to the removal of flying the PRIDE flag at City facilities.

I am currently onto my third PRIDE flag that I display at my home in Huntington Beach. My first one was vandalized within 48 hours of being put up. It was torn straight up the center. I have flown various flags from the front of my home over the last 11 years and this was the first time a flag had been vandalized. The second PRIDE flag I put up, suffered a worse fate when the pole it was being hung on was purposely flung off and broke the bracket at the base. The flag was torn up once again and left on the ground. This attack was witnessed by a person driving by and the suspect fled on foot.

Council Member Burns keeps touting that the US flag represents all of us equally and that is a lie as it has never been true since the colonization of this country. He sees the US flag through the eyes of his privilege as a white man and he is using the supposed "unity" of the US flag to hurt and divide our community by taking away the PRIDE flag.

Every single one of us knows that Americans are NOT treated equally, especially when it comes to their skin color, their race and their standing in the LGBTQ+ community. One only has to look at the high percentage of police killings of Black people to know, that all Americans are not equal under the US Flag. Just last month, we were all witnessed the brutal and abhorrent police killing of a young Black man named Tyre Nichols. Have a look at any statistics on which race is incarcerated disproportionately in this country. Finally, have a look at what is happening in Florida right now with Black history being the sole AP class being removed from school curriculum and LGBTQ+ rights coming under attack.

At the 2/7/2023 Council meeting, these four new council members heard over and over at the podium, how Huntington Beach residents do not want the existing flag policy changed and that the PRIDE flag should continue flying. And thanks to Council Member Moser, who asked for the email tally, we also learnt that 275 total emails were received of which 228 were in opposition to the proposed measure to change the existing flag policy and want to see the PRIDE flag continue to fly at City facilities.

The four new members were elected to non-partisan positions where their job is to represent their constituents' voices. With close to 133,000 registered voters in Huntington Beach according to ocvote.gov, the vote of these four new members does NOT represent all of the Huntington Beach community especially when at most, just over 37,000 voters voted for these four new members. That is nowhere near a majority representation of all of Huntington Beach.

It is clear that from the 2/7/2023 meeting and the majority of emails received, Huntington Beach residents desire to support the LGBTQ+ community and want the PRIDE flag to fly from Harvey Milk Day on May 22nd through the end of June which represents PRIDE month.

I ask that at the next City Council meeting on February 21st, 2023, for Agenda Item 23, that the proposed ordinance is NOT APPROVED so as to keep flying the PRIDE flag as a symbol of unity and acceptance. Vote to show that Huntington Beach is an accepting, inclusive and safe city for their LGBTQ+ residents and all those who visit here.

Dear Mayor and Council Members,

I have sent emails and shared my concerns. I went to the Mayor's Coffee Talk, not to talk, but to quietly show PRIDE in the community where I live. Nothing big, just a small gesture. A gesture to show the LGBTQ+ community in Huntington Beach that there are those who live here who support them and want them to feel safe- like how Whipped Coffee had PRIDE flags on their counter. My being quiet didn't seem to go over well, so now I am writing with an enclosed gift and a question for the Council.

As Council Member Burns left the coffee house, he approached us, the 4 moms and 4 teens standing quietly with PRIDE support and was asked 2 questions:

The first was if he was going to support his claim made during a National Interview on OANN with evidence or concrete numbers from his qualitative-quasi "research" that 4:1 emails were in support of his ordinance, despite the majority of the American Population supporting LGBTQ+ rights (*"Majorities of liberals (81%), moderates (76%), and conservatives (55%) all favor nondiscrimination protections for LGBT people."* - Daniel Greenberg, Emma Beyer, Maxine Najle, PhD, Oyindamola Bola, Robert P. Jones, Ph.D.)

His response was "no"... and then went on to further explain that it wasn't his responsibility to support his claims on a national news network to anyone. As he is an elected official, I respectfully disagree and request that he provide physical evidence to his constituents to support his claim during the meeting.

The second was mine. I have heard his arguments of why he proposed his ordinance, I have ***listened***, and I understand, not to be confused with agree, but I understand. He does not think that ***any*** non-government flags should be flown over governmental buildings, except for the 7 ***he*** stated (Does anyone else think the Olympic Flag, our Sister City's or possibly other flags should be allowed to be flown?). Before I asked my question, I had been thinking about a time, in the 70's & 80's when women were going back to work and schools would ask parents who were at home, to volunteer to place a "Block Parent" sign in their window. (*"Block Parent Program" was a program started in Canada in the 1960's and picked up in San Jose, San Diego etc. in the 70's- in order to protect children*) The gist of the program is that children knew that a home with the sign, was a safe space. The PRIDE flag is often used to mark a location as a safe place for the LGBTQ+ community. That's when I asked Council Member Burns my question. If he would place a PRIDE flag on his property to mark his home as a safe place for his "gay nephew and niece" and their LGBTQ+ friends? He replied that no, they knew his house was a safe place. I am glad that they feel safe at his home. I gestured to the teens that were sitting near me, and asked "Would you hang a PRIDE flag on your private property to mark (your/his) home as a safe place for ***my*** kids?, so that if they ever felt unsafe in his neighborhood, they would know that (your/his) house was a safe place?"

He didn't answer, instead, his response, "YOU people never listen....", ranted, without pause, then left abruptly saying he didn't have time to talk, or in fact listen to anything I or the others present had to say. Ironically, at a City Council "Coffee Talk" he didn't have time to listen, yet he was the one who approached us, outside, and only 2 of us asked questions.

At this same Coffee Talk, Luke Dennis was there. He is obviously friends with Council Members who were present, he supported your campaigns and I am sure you are aware of his record and arrests. Saturday, without provocation, without cause, just because they were holding the PRIDE flags, he filmed the minors I was with. I am familiar with him as in the past he has yelled at me, yelled at my child, spat in my face, posted videos of minors that I was with- in the attempt to dox them (he has posted photos of minors as they were

on school property- is it advisable for a known criminal to film minors at Huntington Beach schools with City Council support?).

These children on Saturday did not feel safe. We didn't feel safe at a local Mayor's Coffee Talk. Please let that sink in. I only brought those children, because I thought "at least the Mayor and Council Members are there- it will be safe". I was wrong. What is wrong in our city where residents don't feel safe in the presence of their Mayor and Council Members?

Council Member Burns stated, "You people don't listen", and I'm writing to say, "I listen. I see. I am afraid for my children's safety in Huntington Beach". I understand that you are going to vote to pass Council Member Burns' ordinance Tuesday, despite him and you implying that you support the LGBTQ+ community and want to keep the LGBTQ+ community safe- because, according to you, you just don't want to fly the PRIDE flag at government buildings- you believe private property is fine. I also understand that you do not want to mark Huntington Beach as a safe city for the LGBTQ+ community.

But will you place this gift of a PRIDE flag in your front window to mark your house, a private residence, as a safe place for my children?

If your answer is "no", even on private property you are unwilling to mark your house as safe for the LGBTQ+ community, I think you need to ask yourself why? My guess is fear.

You are afraid to stand up for a protected class of people- a targeted minority- possibly because of fear you'll alienate your voter base- I am sure it would. Fear that it goes against your religion- if that is the case and your religion believes that LGBTQ+ humans are not worthy of being protected, then you don't really support the LGBTQ+ community, and you should just be honest and say that tonight at the meeting. Fear that there are people, like Luke Dennis who would target you? ... that is a valid fear, one I have. I wonder how any of you would feel if Luke Dennis spat in your face, how would you feel if he took photos of your children and posted them online, if he or his "Proud Boy" friends showed up at your business... or your home unannounced- if he was angry with you?

Whatever fear you have of publicly supporting the LGBTQ+ community in your private life... I assure you that it is nothing compared to the fear the children in the LGBTQ+ community in Huntington Beach have daily. You voting to no longer mark Huntington Beach as a safe space for the LGBTQ+ community, will give reason, give power, give support to criminals like Luke Dennis to hurt people, family members, like Council Member Burns' niece and nephew.

I chose not to sign my name, as Council Member Burns has made it clear with his reactive response on Saturday that he is unsafe for my family, but I am your constituent, I live in Huntington Beach- and I wish you to know the peace that one day I hope the LGBTQ+ community can feel in this city.

As a frequent patron of Huntington Beach businesses and an Orange County resident, I join with the majority in the community respectfully requesting that the City Council approve keeping the rainbow flag at City Hall.

Flying the rainbow flag is a wonderful and symbolic way to show our city is inclusive while engaging the entire Huntington Beach community and showing support of LGBTQ community. It is also a fantastic way for us to spur local business growth, and not incur the type of penalties that we have seen recently with companies not investing in Huntington Beach because of the lack of support for our LGBTQ community.

As you know, Harvey Milk was the first openly gay elected official in California, when he won a spot on the San Francisco Board of Supervisors in 1977.

In 1978, under his urging, the city council passed a gay rights ordinance that protected gay people from being fired from their jobs. Less than a year into his first term, Milk and San Francisco Mayor George Moscone were shot and killed in City Hall by former Supervisor Dan White.

Milk opened the door to a generation of LGBT elected officials in California who felt like they could be political players without hiding who they were.

In California, May 22 is Harvey Milk Day, recognized by the state's government as a day of special significance. Public schools are encouraged to hold lessons "remembering the life of Harvey Milk, recognizing his accomplishments and familiarizing pupils with the contributions he made to this state."

In 2009 Milk was awarded the presidential medal of freedom, the country's highest civil honor. He was one of the first 16 recipients of the honor chosen by President Barack Obama.

By flying the pride flag at City Hall, we display the spirit of diversity and inclusion that has helped make Huntington Beach a wonderful place for our employees and customers to live, work and play.

To the Four New Members of Huntington Beach City Council,

As a 20 year resident of Huntington Beach, I am writing to express my opposition to the removal of flying the PRIDE flag at City facilities.

I am currently onto my third PRIDE flag that I display at my home in Huntington Beach. My first one was vandalized within 48 hours of being put up. It was torn straight up the center. I have flown various flags from the front of my home over the last 11 years and this was the first time a flag had been vandalized. The second PRIDE flag I put up, suffered a worse fate when the pole it was being hung on was purposely flung off and broke the bracket at the base. The flag was torn up once again and left on the ground. This attack was witnessed by a person driving by and the suspect fled on foot.

Council Member Burns keeps touting that the US flag represents all of us equally and that is a lie as it has never been true since the colonization of this country. He sees the US flag through the eyes of his privilege as a white man and he is using the supposed "unity" of the US flag to hurt and divide our community by taking away the PRIDE flag.

Every single one of us knows that Americans are NOT treated equally, especially when it comes to their skin color, their race and their standing in the LGBTQ+ community. One only has to look at the high percentage of police killings of Black people to know, that all Americans are not equal under the US Flag. Just last month, we were all witnessed the brutal and abhorrent police killing of a young Black man named Tyre Nichols. Have a look at any statistics on which race is incarcerated disproportionately in this country. Finally, have a look at what is happening in Florida right now with Black history being the sole AP class being removed from school curriculum and LGBTQ+ rights coming under attack.

At the 2/7/2023 Council meeting, these four new council members heard over and over at the podium, how Huntington Beach residents do not want the existing flag policy changed and that the PRIDE flag should continue flying. And thanks to Council Member Moser, who asked for the email tally, we also learnt that 275 total emails were received of which 228 were in opposition to the proposed measure to change the existing flag policy and want to see the PRIDE flag continue to fly at City facilities.

The four new members were elected to non-partisan positions where their job is to represent their constituents' voices. With close to 133,000 registered voters in Huntington Beach according to ocvote.gov, the vote of these four new members does NOT represent all of the Huntington Beach community especially when at most, just over 37,000 voters voted for these four new members. That is nowhere near a majority representation of all of Huntington Beach.

It is clear that from the 2/7/2023 meeting and the majority of emails received, Huntington Beach residents desire to support the LGBTQ+ community and want the PRIDE flag to fly from Harvey Milk Day on May 22nd through the end of June which represents PRIDE month.

I ask that at the next City Council meeting on February 21st, 2023, for Agenda Item 23, that the proposed ordinance is NOT APPROVED so as to keep flying the PRIDE flag as a symbol of unity and acceptance. Vote to show that Huntington Beach is an accepting, inclusive and safe city for their LGBTQ+ residents and all those who visit here.

Why is SB 10 included in the agenda item? The agenda item does not explain what SB10 is or how it may affect the City's existing zoning. It appears unlikely to substantially affect the City, since, per the text of SB 10, the area for housing development must be "urban infill, consistent with the definition of used in SB 35 (2017), or be near high quality public transportation or a job-rich area."

Where would this area be within the City of Huntington Beach?

Important topics such as this must be subjected to a more thoughtful approach. Any future agenda item on this topic should include more facts and analysis and in particular more historical context. Doing this will assist Huntington Beach residents in understanding the vote that the Council members are considering and the impact the decision may have on them.

As a frequent patron of Huntington Beach businesses and an Orange County resident, I join with the majority in the community respectfully requesting that the City Council approve keeping the rainbow flag at City Hall.

Flying the rainbow flag is a wonderful and symbolic way to show our city is inclusive while engaging the entire Huntington Beach community and showing support of LGBTQ community. It is also a fantastic way for us to spur local business growth, and not incur the type of penalties that we have seen recently with companies not investing in Huntington Beach because of the lack of support for our LGBTQ community.

As you know, Harvey Milk was the first openly gay elected official in California, when he won a spot on the San Francisco Board of Supervisors in 1977.

In 1978, under his urging, the city council passed a gay rights ordinance that protected gay people from being fired from their jobs. Less than a year into his first term, Milk and San Francisco Mayor George Moscone were shot and killed in City Hall by former Supervisor Dan White.

Milk opened the door to a generation of LGBT elected officials in California who felt like they could be political players without hiding who they were.

In California, May 22 is Harvey Milk Day, recognized by the state's government as a day of special significance. Public schools are encouraged to hold lessons "remembering the life of Harvey Milk, recognizing his accomplishments and familiarizing pupils with the contributions he made to this state."

In 2009 Milk was awarded the presidential medal of freedom, the country's highest civil honor. He was one of the first 16 recipients of the honor chosen by President Barack Obama.

By flying the pride flag at City Hall, we display the spirit of diversity and inclusion that has helped make Huntington Beach a wonderful place for our employees and customers to live, work and play.
