INTRODUCTION

 Chris Slama introduce Kristin Martinez, who was recently promoted to Community & Library Services Manager for the Programs and Services Division. Martinez was most recently the Supervisor at the Senior Center in Central Park. Martinez has many years of service with the City in recreation, including service at Murdy Community Service and the City Gym and Pool.

PUBLIC COMMENTS - None

APPROVAL OF MINUTES

1. Chair Mantini called for a motion to approve the minutes of June 9, 2021. Commission Pike moved to approve with Commissioner Burns seconding the motion. All in favor (approved 4-1 Kemmerer absent).

ADMINISTRATIVE ITEMS

- 1. **Election of Chair and Vice-Chair** The annual election of Chair and Vice Chair were conducted as follows:
 - a. Commissioner Pike moved to nominated Commission Mantini to remain as Chair. Commissioner Burns seconded the motion. All in favor. (Approved, 4-1 Kemmerer absent).
 - b. Chair Mantini moved to nominate Commissioner Pike as Vice Chair. Commissioner Burns seconded the motion. All in favor. (Approved, 4-1 Kemmerer absent).

DIRECTOR'S ITEMS -

1. Slama reported that City Council approved the temporary ice skating rink at pier plaza during the winter months. The venue is scheduled to open November 26, 2021. More to follow next month.

INFORMATIONAL ITEMS

- 1. Commission Business
 - a. Slama announced the resignation of John Partington. Staff is awaiting a replacement by Councilmember Kalmick. Additionally, Councilmember Bolton is researching and conducting interviews of potential appointees as her representative on Commission.

2. Master Plans Updates

- a. Parks & Recreation 5-year Master Plan in Process Slama reported that the Master Plan updated kicked off in May 2021. The City has been working with RJM Design Group, landscape architect, on surveys and workshops since June. Workshop #3 is schedule for September 23, 2021, which will discuss the results of online surveys received to-date from the public. Slama provided an overview of the remaining process, which he said could be found at http://bit.ly/hbparksmasterplan2021. The updated Master Plan will come to Commission for review prior to going to City Council for final approval. Mantini asked if the mobile homes at Oceanview Estates would be discuss. Slama reported that a Central Park Master Plan will be forthcoming that will include the mobile homes and several other improvements not listed in the current Central Park Master Plan.
- b. Edison Park Master Plan in Process Slama reported that the Edison Park Master Plan was running concurrent with the Parks & Rec Master Plan update. He provided an update on what had taken place to-date, including the conceptual plan kick-off and online workshops. The next workshop will be an in-person charrette workshop scheduled for 6pm on September 15, 2021 at Edison Park. More details at www.bit.ly/hbedisonpark.com.

3. Improvements and Playgrounds Update

a. Bluff Top Railing – Groundbreaking is scheduled for 10 am on September 14, 2021. This project is scheduled in phases. First phase is to replace the deteriorated railing. Slama invited the Commission to join the groundbreaking ceremony. Mantini asked about the ground squirrels. Slama said that the landscape architect and staff were looking at options for mitigation. The project will include path improvements, a sidewalk along PCH, and landscaping improvements. Discussion had been made on the speed of the

bike versus the pedestrians. A separated portion will be designated for pedestrians, delineated from the bikes, in addition to enhancing the "crossing zone". Project completion anticipated by Memorial weekend of 2022. Mantini asked about the railing material. Slama said that there would be a combination of aluminum railing and lodge pole.

- b. Central Park West Playground Slama provided images that were previously presented to Commission. He reported that the contractor would be sectioning off the area tomorrow, September 9, 2021. A ribbon cutting is anticipated for early November.
- c. Sun View Prop 68 Playground This Park is on the approved playground improvement list. Looking for construction to begin in 4-6 weeks.
- d. Glen View Playground This Park is also on the playground equipment improvement list. The playground equipment will be fully replaced. The funds were allotted in the current CIP year.
- e. Rodgers' Senior Center Site This project is in the final plan check stage and will go to the Public Works Commission next week. Once approved, it will go out to bid. Slama said the hope is to break ground in 2-3 months.

4. Community & Library Services Programs Report – Martinez

- a. Slama introduced Martinez again, who reported on programs and services. Martinez presented a slide show saying that this year allowed for more inperson events, including overnight camping event in Central Park for 235 campers. Some of the statistics included a pier swim on June 12, 2021 with 226 swimmers. There was a movie series throughout the summer held at a different parks for each event; Camp HB at Murdy Center with 282 participants; and a 2-week sports camp for the Oak View youth with 28 participants. The contracted camps, which included recreation, education, and surf camps attracted 1,537 participants. Aquatics brought in 495 students for swim lessons and 130 families for recreation swim. Aqua Aerobics and Aqua Tone had 215 participants. Youth sports included Pee Wee T-B and Jr. Baseball with 53 participants; Pee Wee Basketball and Junior Basketball has 38 participants for 91 participants. Contracted sports Camps had a total of 505 participants. As a whole, over 7,000 participants registered for programs.
- b. The Senior Center turned 5 years old this year and was very busy. Staff will be looking for stories and testimonials throughout the year to celebrate the first 5 years. In-person contract classes and virtual classes are both running now.

3 trips were taken over the summer. The fitness center and game rooms are open again. Outdoor Summer Concert has 352 participants. The Outlook on Active Aging has had handed out 25,000 copies so far this year. 66,300 homedelivered meals were served. Walk up service is available on Tuesdays. Care management has had 2000 inquires this year. A staggering 6,541 Surf City Seniors On The Go rides provided were in 2021; professional services and volunteers have returned as well.

c. Martinez also provided information on programs coming this fall, including Adaptive Swim, which is new this year. Various events are scheduled and details can be found on the on the Senior Center's website.

SUBJECT: EDISON COMMUNITY PARK RECONFIGURATION –

CONCEPTUAL PLAN

<u>Statement of Issue</u>: Staff has worked with RJM Design Group to conduct a public input process and develop a conceptual plan to make needed improvements at Edison Community Park (Edison Park). There is a need for the Community and Library Services Commission to review the conceptual plan and make a recommendation to City Council for approval.

Financial Impact:

Not applicable

Recommended Action:

Approve the conceptual diagram for Edison Park reconfiguration and forward to City Council for their consideration.

Alternative Action:

Do not approve the recommended action and direct staff on how to proceed.

Analysis:

Edison Park, located at 21377 Magnolia Avenue, was constructed in the early 1970's and was opened to the public in 1974. Since that time, the 40 acre park has functioned as one of the main recreation facilities in the City. With multiple sports facilities and a community center building, Edison Park offers a wide range of programs for sports leagues, cultural and recreation classes to meet the recreational needs of the public.

Development Background

In the past, Commission and City Council have approved changes to the park in order to keep up with recreational programing trends and demographic changes. One such change occurred in 2010 when approval was given to reconfigure portions of the park to function as a youth sports complex. At the time, the Fountain Valley School District decided to sell Wardlow and Lamb Schools. The Huntington Beach City School District was also in early discussions to consider claiming LeBard and Kettler Schools as surplus. Each of the four school campuses included multiple sports fields utilized by local non-profit youth sports organizations. Facing the possibility of losing the school sports fields, a master plan was created to develop multi-use sports practice fields, a competition level soccer field, and additional parking at Edison Park. The approved master plan update for the park was designed to be completed in four phases. Phase I was completed in 2011 and included additional parking to the south of the community center building and three multi-use, lighted practice fields running parallel to Hamilton Avenue. Additional phases were to include more parking at the northeast section of the park and the competition level soccer field to be an overlay on the two existing softball fields.

The City was later able to purchase areas at certain closed school sites, which acquired:

- 6 acres of land at Wardlow School, preserving six baseball fields utilized by Huntington Valley Little League
- 2.6 acres at Lamb School, preserving a lighted soccer field to be utilized by AYSO
- 6.6 acres at LeBard School, preserving the ballfields being used by Seaview Little League

The ability to preserve these fields eliminated the need to provide additional youth sports fields within Edison Park at that time, so the remaining three phases of the Edison Park Master Plan were not executed.

Today, existing park amenities at Edison Park include two lighted softball fields, three lighted multi-use practice field areas, four tennis courts, four full and four half-sized basketball courts, six outdoor racquetball courts, open turf areas, walkways and a 17,361 square foot community center building and parking. The interior of the community center was remodeled in 2021, modernizing the building and improving the functionality. A temporary skate spot was also recently developed in the location of the former picnic shelter area to utilize space during the Edison Park community outreach and design phases.

Sections of the park have been affected by land settlement over the years. A portion of the park was developed over a former construction material landfill. While the former landfill is mainly covered with turf, there are certain park amenities that have been impacted. Sections of the existing tennis courts are located within the landfill limits. The courts were constructed with a post-tension slab design in an effort to minimize settlement issues, however, two of the four courts have shifted to the point of creating severe grade changes and developing cracks in the concrete playing surface. These two courts are no longer in use by the public. Sections of the tot playground and softball field areas have also shown significant settling.

In an effort to get a better understanding of the landfill conditions and to determine feasible park improvements, staff consulted with a geotechnical engineering firm to conduct a subsurface investigation of the site. A copy of the report is available on the Community Services webpage for public review. In anticipation of a need to relocate amenities or

repurpose sections of the park, staff began looking at design options not only within the limit of the former landfill, but throughout the park. Since the park was constructed over four decades ago, there was a need to assess the current park layout and amenities, and consider options for reconfiguring the park to meet current demands and enhance recreational opportunities.

Additionally, the Huntington Beach City School District is currently in the process of selling the Gisler School site to a private developer. This closed school site also featured a large field space with lighting, which has traditionally been utilized by AYSO Region 56 for youth soccer. Staff has coordinated with HBCSD, City Council, and AYSO leadership in an effort to identify alternate options for soccer field space. The pending reconfiguration of Edison has been identified as a feasible opportunity to provide significant soccer field space.

While the formerly approved youth sports complex concept at Edison is no longer completely relevant, new recreational trends and input from the public have generated a need to develop a revised master plan for the park. To address the current issues and need for Edison Park rehabilitation, staff has consulted with RJM Design Group to develop a conceptual master plan that proposes both new and relocated amenities.

Public Outreach

Development of the 2021 conceptual plan included extensive community outreach. Staff and RJM solicited public input in the form of two virtual on-line surveys, an in person community survey meeting, and an in person design charrette conducted at the Edison Community Center. Each virtual survey was open for two weeks. Survey 1 received 160 responses, focusing on how Edison Park is used for recreation, what is most liked and disliked about the park, what improvements can be made, and what amenities should be added. Survey 2 received 295 responses, focusing on what respondents felt were the most important active and passive amenities, as well as maintenance and site improvements. Utilizing this data, 45 residents participated in the in-person design charrette, which included an awareness tour around the park. Attendees were separated into multiple groups, provided a scaled park site plan and various amenity and facility templates, and were tasked with working together to prepare a plan of preferred park improvements. A dedicated project website was also created and linked on the Community & Library Services Department webpage in an effort to keep the public informed as the project reached various milestones. Additionally, a "Feedback" button will continue to be active through the life of the development of the master plan, ensuring residents can continue to provide feedback until the master plan has been approved by City Council.

Proposed Improvements

Based on the community input received and professional analysis, RJM Design Group has prepared a conceptual master plan that includes repurposing sections of the park, enhancing some existing facilities and introducing new amenities. Main items of the proposed plan are:

- Reconfigured parking lot with enhanced entries
- New basketball courts (4 full and 4 half-court)
- New dedicated tennis courts (2)

- New dedicated pickleball courts (8) on two of the existing tennis courts
- New dual striped courts (2 tennis, or 8 pickleball)
- New sport court plaza with seating and shade
- Enclosed dog area with water, seating, and shade
- Reconfigured walkways
- New trees
- New shade shelter
- New outdoor exercise stations
- New tot lot with rubberized surfacing, equipment and shade
- 4 new U-10 youth soccer overlays, with 2 full size overlay options
- Enlarged skate area
- New pump track
- Reconfiguration of existing batting cages
- New park restrooms and concession stand near softball fields
- Expansion of the exterior community restrooms

Project Development Process/Timeline

Pending approval by the Commission and City Council, the next step in the process would be the development of detailed engineering plans and specs, including preparation of a preliminary construction estimate. Funding in the amount of \$300,000 has been included in the City's FY 21-22 Capital Improvement Program (CIP) for Edison Community Park preliminary design services. Additional funds will need to be identified and budgeted as the project proceeds through the various design and construction phases.

<u>Environmental Status</u>: N/A at this time. The appropriate environmental process will be followed as directed by the Planning Division of the Community Development Department once a re-use option is determined.

SUBJECT: MEMORIAL PLAQUE RECOGNTION FOR RICK "ROCKIN' FIG"

FIGNETTI

Statement of Issue:

At the direction of City Council, the Community & Library Services Commission is to make recommendation on the concept and placement of a public memorial honoring Rick "Rockin' Fig" Fignetti.

Funding Source:

Not applicable. Design and purchase of the plaque will be funded by the Greater Huntington Beach Interfaith Council.

Recommended Action:

Make a recommendation to City Council to approve the design concept and placement of a memorial plaque honoring Rick "Rockin' Fig" Fignetti at Tower Zero on the Huntington Beach Municipal Pier.

Alternative Action:

Do not approve the recommended action and direct staff on how to proceed.

Analysis:

Fignetti was a beloved member of the City and the surfing community. Due to the recent passing of this prominent resident, surfer, business owner, and celebrity, Mayor Kim Carr and Mayor Pro Tem Barbara Delgleize introduced Item 21-664 (Attachment 1) in response to community recommendations to honor Fignetti's contributions to the City. The request was approved by Council on September 7, 2021, which directed the Community & Library Services staff and Commission to work with the surfing community, the Greater Huntington Beach Interfaith Council, and to keep the Fignetti family informed regarding the proposed public memorial to honor Fignetti.

The Council item also asked for the inclusion of the Historic Resources Board (HRB) in the proposal process. Staff reached out to Kathie Schey, Chair of the HRB, who indicated

that since this item was not of historical significance, formal review by the HRB was not necessary.

The Greater Huntington Beach Interfaith Council has also come forward in support of a memorial honoring Fignetti. They have committed funds to purchase a memorial plaque to include information and an image of Rick "Rockin' Fig" Fignetti.

Fignetti had been referred to as the "Voice of Surfing" for over 25 years. Calling in the day's surf conditions to local FM radio station, KROQ from 1984-2010, surfers all over Southern California knew his voice.

In addition to his love for surf, Fignetti became a celebrated announcer for local and legendary surf events, including the US Pro Tour (1987-2002), OP Pro, The US Open of Surfing (16 years) and the NSSA Nationals (20 years) to name a few. According to Fignetti's friend and long-time Huntington Beach resident, Don Ramsey, "Figgy also announced the Jacks Pro, and the Surf City Splash. [He] was also the announcer for the Int'l Surfboard Builders Hall of Fame since it moved to HB, and was the main speaker at all of the Memorial Paddle Outs for the last 10 to 15 years." Fignetti was a surf journalist as well with over 20 years of writing columns such as Wet n Wild for the HB Independent, and O.C. Live for the Los Angeles Times.

Before announcing, Fignetti's love for surfing competitively began in 1978, when he entered his first contest, and it continued for 40 years. Fignetti was a ten-time West Coast Surfing Champion, two-time National Surf Champion, and inducted into the Surfers' Hall of Fame in 2010.

Additionally, Fignetti was a well-known business owner Rockin Fig Surf Shop Headquarters on Main Street for many years. Over the years, Fignetti employed hundreds of youth to work in his shop to learn the art and discipline of shaping boards.

As part of City Council's action item discussion, Tower Zero was mentioned as a location for the memorial plaque. There are two existing plaques located in the proposed location on Tower Zero. One plaque honors former Marine Safety Chief and Community Services Director, Max Bowman, and in 2018, a second plaque was added to the Tower in honor of Father Mondor and Pastor Sumo. It is recommended that the memorial plaque for Rockin' Fig be placed adjacent to the Max Bowman plaque and above the Mondor/Sumo plaque. As previously stated, the Greater Huntington Beach Interfaith Council will fund the design and fabrication of the plaque.

Resolution 2017-25 states that all recommendations for memorial recognition on public facilities be processed through the Community & Library Services Commission (formerly Community Services Commission), which shall make recommendation to the City Council for final approval. Per City Council direction, staff is recommending the design and placement on Tower Zero. The final design and verbiage for the plaque is being developed. At this time, Commission is being asked to consider and make recommendation on the design concept and placement of the plaque on Tower Zero.

37. 21-659 Approved Item Submitted by Councilmember Kalmick — Conduct a Feasibility Analysis regarding the possible relinquishment of Pacific Coast Highway (PCH) to improve vehicle and pedestrian safety

Councilmember Kalmick introduced this item by explaining that Caltrans operates Pacific Coast Highway as a state highway and not a city street. He described areas where other cities have paid Caltrans to allow them local control of various roadways, and stated this effort is to start the process to find out what would be required to improve public safety.

Mayor Pro Tem Delgleize expressed her support for this item, and offered to reach out to Orange County Transportation Authority (OCTA) for assistance if staff desired.

Councilmember Moser stated her support for this item and determining how gaining control could impact the Downtown area design efforts.

Councilmember Posey stated his support, and asked why Beach Boulevard wasn't included. Councilmember Posey stated his expectation that the Feasibility Analysis will include ongoing liability as well as initial costs.
