#### **CALL TO ORDER**

### **APPROVAL OF THE MINUTES**

### **DISCUSSION ITEMS**

1. October 2021 Monthly Report

Commissioner Burtis provided an update on the increasing arrivals into Long Beach Airport that during November up to about an average of 45 per day. The elevation of the flights as they come across the coastline in Huntington Beach 68% of the SWA flights and only 32% of the HAL flights are above 2,500 feet.

### 2. Updates:

a. Meeting with US Representative Steel's Office

Chair Morin provide an update of the meeting with Representative Steel and her staff. Information on the history of jet noise impacts for Huntington Beach was provided, the progress the Jet Noise Commission has made working with Long Beach Airport and Southwest Airlines, and the discussions with FAA. Rep Steel will have her staff work with the Commission on a letter requesting that the FFA cooperate and work with local agencies on the impacts to the community. Representative Steel stated that her office will reach out to Representative Lowenthal and request support for this effort.

b. Discussions with Airlines and Long Beach Airport

Assistant City Manager Hopkins provided an update with discussion with Long Beach Airport staff and Southwest Airlines. The recent discussion are reviewing options moving forward with the airlines to have voluntary compliance with the 3 degree glide slope. Contact was made with Hawaiian Airlines Director of Airport Operations requesting a meeting with appropriate airline representatives to discuss the commission concerns.

### 3. Next Steps of Address and Jet Noise Concerns

Discussion of potential next steps was discussed by the commission. Commissioner Kunze suggested preparing news articles providing a positive light for airlines that are voluntarily working with their pilots to fly utilizing the 3 degree glide slope while approaching LGB which minimizes the noise impact to Huntington Beach residents. Additionally other media outlets including social media were also discussed. The Commission requested that in a future meeting with LGB that information on the environmental plans and goals are requested and discuss with them the environmental and cost impacts due to fuel saving by utilizing the 3 degree glide slope.

Commissioner Bourgeault suggested reviewing the availability of city resources to provide support to Commissioner Burtis data collection and review.

The Commission discussed the next meeting dates and canceled the December 2021 and adjourned to the next meeting is scheduled for January 24, 2022.

### Air Traffic Nationwide




Figure 1 - TSA Passenger Count Aug 2020 through Aug 2021




Figure 2 - TSA Passenger Count Jan through Aug 2021

Figure 1 shows the TSA passenger count for the last rolling 12 months of activity and Figure 2 shows the count for just this calendar year.

# **Air Traffic over Huntington Beach** LGB

Figure 3 shows the LGB arrivals. It varies by a few flights per day but averages out at 44 flights per day which is 10 flights per day up from previous months. The bottom line is from August of 2021 and the top line is from November.

### **LGB Arrivals from Hawaii**

Hawaiian flights continue to be a puzzle. Table 1 shows the percentage of coast altitudes by flight based on whether  $\geq$  2500' or not. 30% / 70% vs 20% / 80% depending of HAL70 or 72 seems odd. This has really not changed much, and SWA is still basically 50% / 50% for all Hawaiian flights.

We have reached out to HAL and have made contact and a promise of a call, but have not yet agreed on a date for a conversation.

### **Overview**

The purpose of this report is to give an update on commercial jet traffic over the City of Huntington Beach. This is a very high level summary and does not contain all the underlying data and explanations.

This report covers air traffic over Huntington Beach from December 1st to December 31st, 2021.

### Air Traffic Nationwide

Figure 1 shows the TSA passenger count for 2019-2021. Note that starting about mid-June that the shape of the 2021 curve matches the 2019 curve.




Figure 2 - TSA Passenger Count for 2021 compared to 2019

Figure 2 expands on that and shows the percentage comparison of 2021 to 2019. By roughly July 1<sup>st</sup> the percentage was around 80% and stayed that way the rest of the year.



Figure 1 - TSA Passenger Count 2019 through 2021

# **Air Traffic over Huntington Beach** LGB




Figure 3 - LGB Arrivals by Day for 2021

Figure 3 shows the LGB arrivals for all 365 days of 2021. Note that in November SWA added several flights taking arrivals from averaging roughly 35 to 45.

### LGB Arrivals from Hawaii




Figure 4 - HAL 70 v HAL72 Altitude by Day

Hawaiian flights continue to be a puzzle. Table 1 shows the percentage of coast altitudes by flight based on whether >= 2500' or not for both HAL and SWA. While this has been a pretty standard difference, a funny thing happened in December. Whereas before HAL70 and HAL72 behaved differently, in December they both were at 33/67%. Figure 4 shows HAL 70 and HAL72 altitudes by day in December; some says they line up, some days they're quite different. On average they are about 90 minutes apart.

### What will happen in January?

We have reached out to HAL and have made contact and a promise of a call, but have not yet agreed on a date for a conversation.
