**CALL TO ORDER**

**PUBLIC COMMENTS**

*One person provided comments that he lives on the Southeast side of the City and has noticed increased noise due to SNA traffic.*

**APPROVAL OF THE MINUTES**

*Approval of the minutes from May 23, 2022 as amended.*

**DISCUSSION ITEMS**

1. Review of Air Traffic Reports

*Commissioner Burtis shared data collected and comparison charts. Charts including passenger counts for the past month have reached high points for the year. He reviewed the incoming flights for SWA and HAL reviewing the arrivals above 2,500 feet in elevation. HAL has increased the number of flights arriving at elevations above 2,500 feet crossing the coast line by 10%. A review of the number of flights over Huntington Beach with destination to Long Beach Airport, Santa Ana Airport and Los Angeles International Airport.*

*The Committee discussed the impact of LAX bound cargo flights over Huntington Beach seem to be causing the most noise. Although these flights are between 6,800 and 7,100 feet in elevation reasons for the noise impact may be attributed to the large 747 cargo planes are likely fully loaded and arrive at all hours day and night.*

2. Updates:

a. Congress Members Steel and Lowenthal FAA Letter Update and Discussion

*The letter from Congress Members Michele Steel and Alan Lowenthal has been submitted to the FAA Acting Administrator requesting assistance to meet with local community representatives such as the Huntington Beach Jet Noise Committee concerning impacts of the*

*NextGen project. The committee discussed options to utilize this letter to provide positive press on the efforts of the Congress members and the committee. Commissioners requested that staff share the letter with the FAA Ombudsman, Airlines and Long Beach Airport showing the committees commitment to reducing the jet noise impact to the community.*

**b. Airlines and Long Beach Airport Update**

*City staff continues to request the use of the noise monitoring equipment from Long Beach Airport. The Airport is re-evaluating the City of Huntington Beach use of the equipment and if there would be any requirements to do so. City staff is following up with the opportunity to meet and discuss with them. City staff with the help of Long Beach Airport staff, is reaching out to Southwest Airlines to identify a chief pilot to help support ongoing discussions on the Committees noise efforts.*

**c. FAA Ombudsman Update**

*Since the May 23 Jet Noise Committee meeting there has not been contact with the FAA Ombudsman. Staff will continue to request discussions on options that would increase the elevation of the Hawaiian Airlines flights over our community.*

**d. Noise Study Update**

*With the uncertainty of the use of LGB noise monitoring equipment staff will pursue other options with the city consultant and evaluate cost as well as access to data required for the study.*

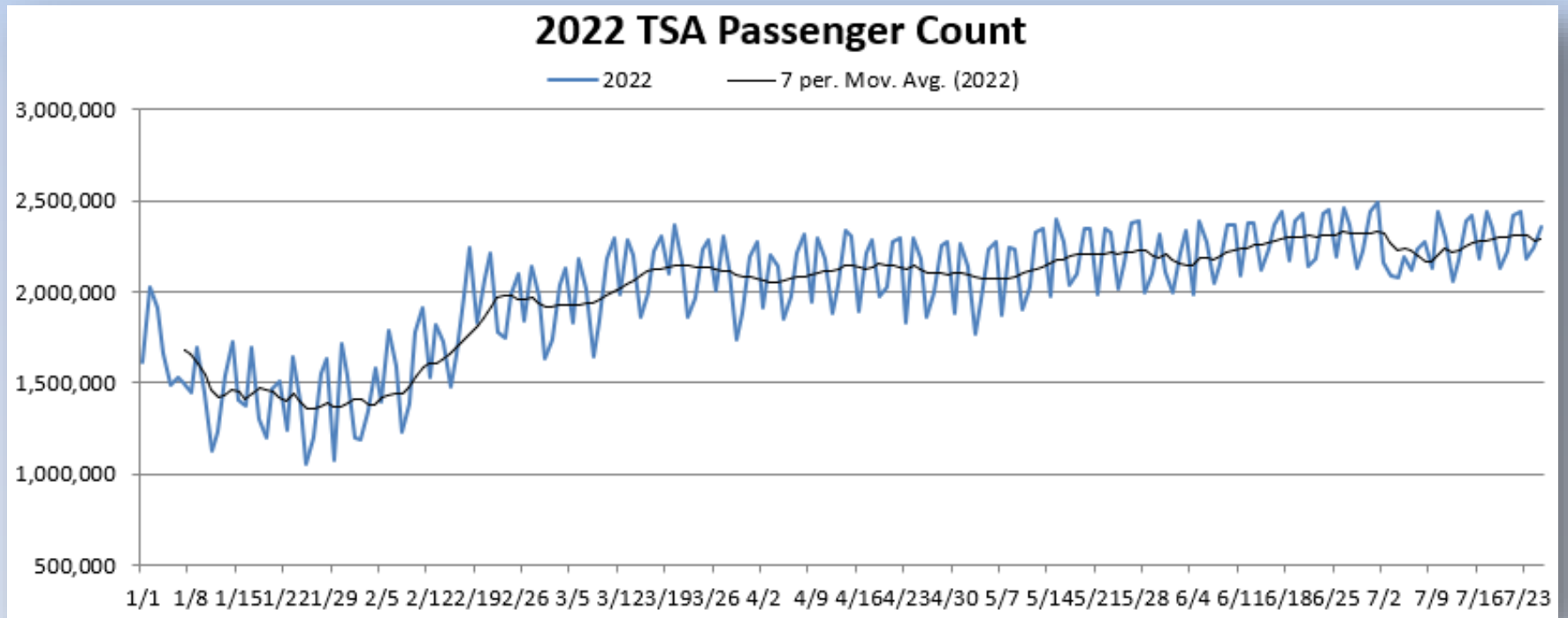

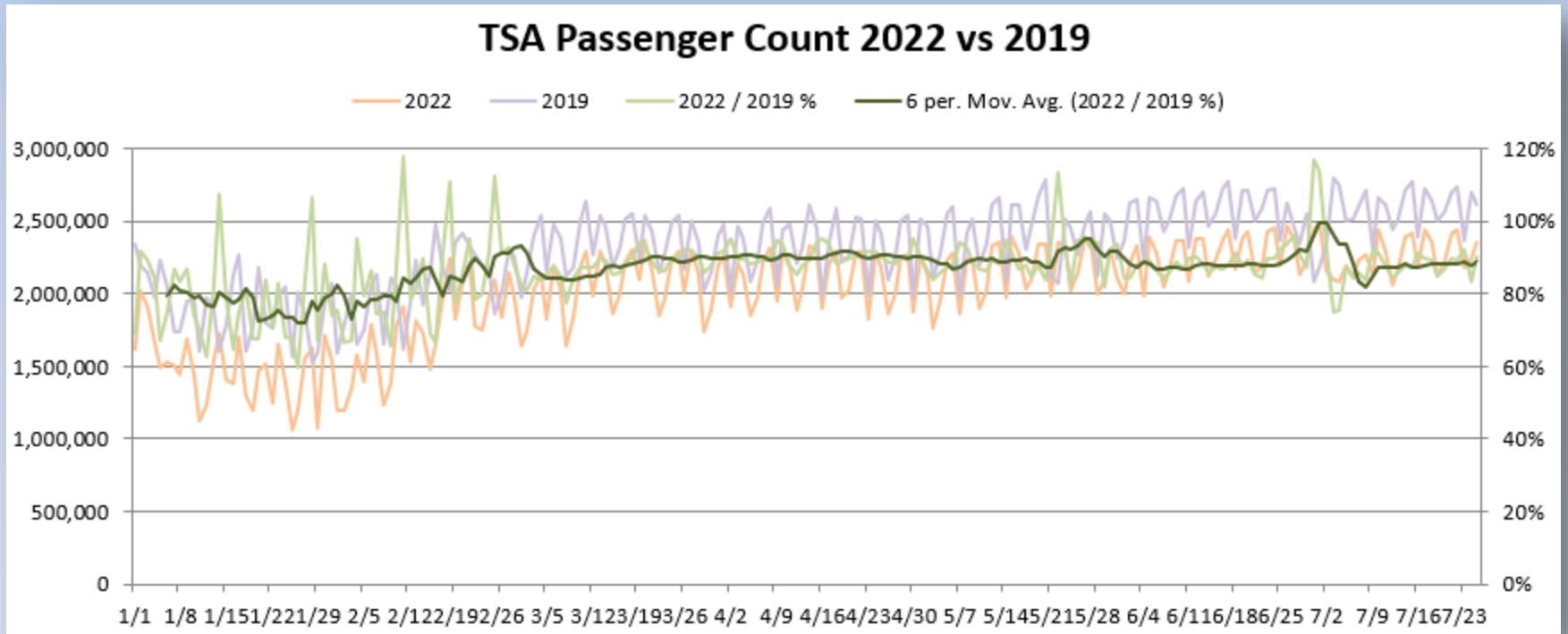

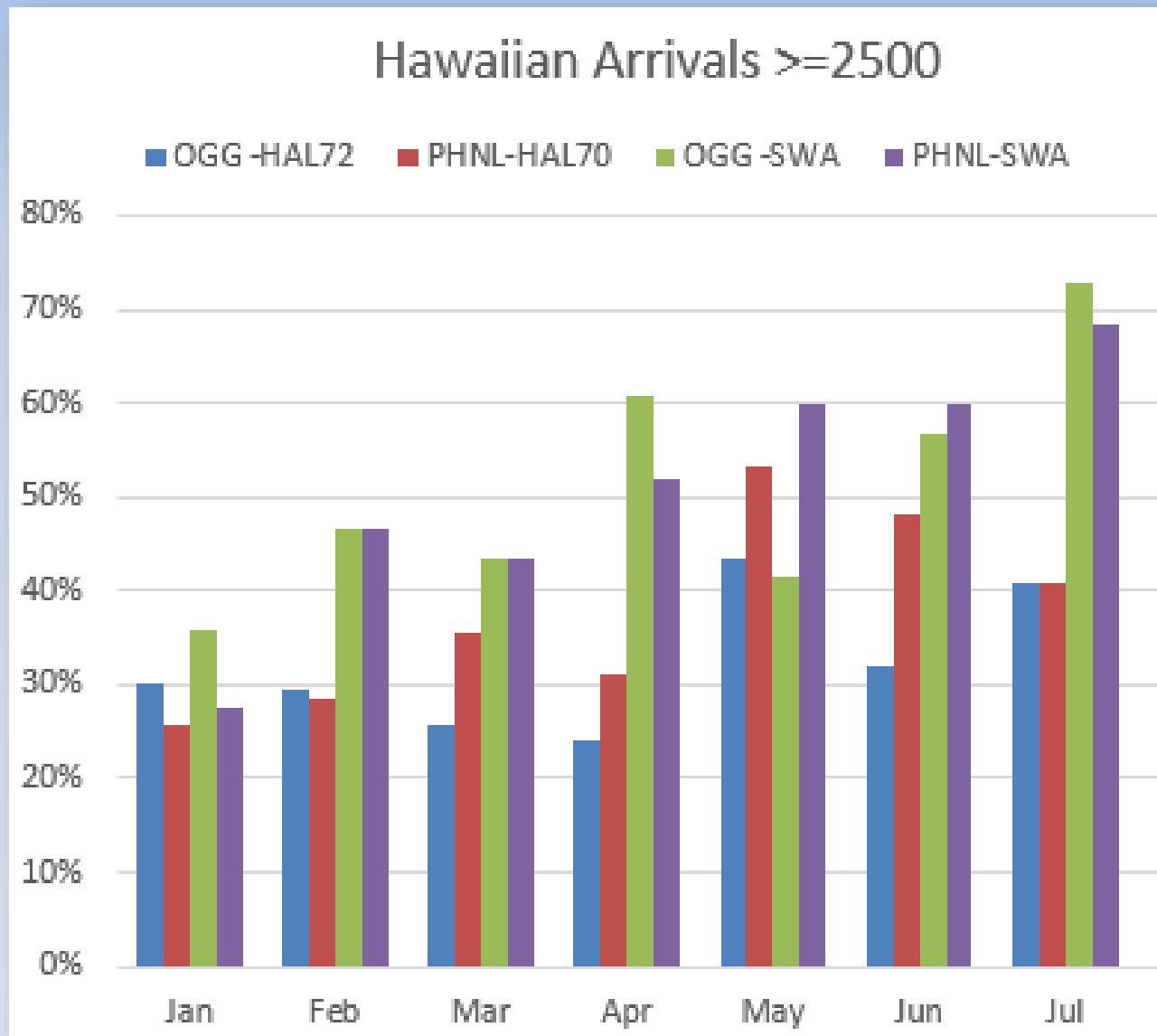
# TSA Passenger Count 2022

# LGB Hawaii Arrivals



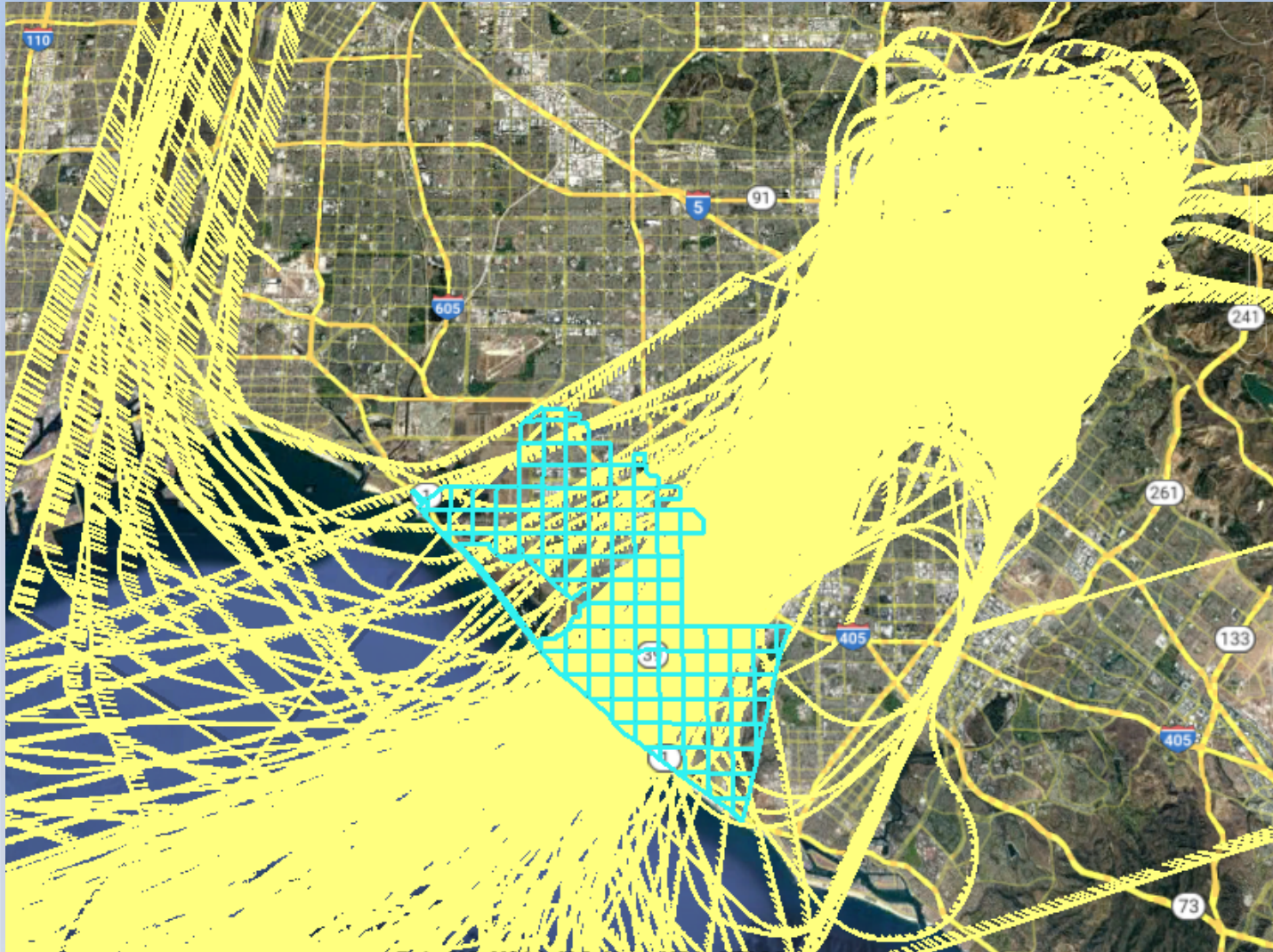


# LGB 1,075 Arrivals over HB in July!
