WHEREAS, the proposed ordinance is expected to be presented to the Huntington Beach City Council for adoption at its February 21, 2023 City Council meeting; and

WHEREAS, since 2021, the City of Huntington Beach has displayed the Pride flag for six weeks each spring in honor of Pride Month in June; and

WHEREAS, since the City of West Hollywood's incorporation in 1984, the City has advocated for measures to support LGBTQ individuals and has been in the vanguard on efforts to gain and protect equality for all people on a state, national, and international level.

This boy became a paper boy who delivered newspapers throughout his neighborhood, on his route, there was a house where two men resided, for a young boy the fact that two men shared a house meant nothing to him but he did recognize one of the two was the piano player from the church he attended and the other man he saw wearing a robe and a hood on occasion like used in the catholic church as some leaders wore. The one man from our church when I came to their house to deliver his paper offered to drive me on my paper route to deliver my papers, I thought it was a kind gesture from a church member so I accepted the ride. While we were driving through the neighborhood the man asked if I had hair under my arms or on my pubic area (my balls). I thought that was an odd question but I did not understand, then he began reaching for my leg close to my genitalia like he was tickling me, and I rebuffed his efforts. When I got home my mother said she got a call from a neighbor to tell her she saw me in the car with our new Gay Couple Neighbors and not to get near them and never get in their car, I did not understand gay or even what it meant, but now I know I was being Groomed by a Gay Man for his sexual pleasure. That Young Boy was me.

Growing up in the 1960s as a teen I Hitch Hiked and was a normal form to get around, and I hitchhiked to get to friends' house, I had called my friend to let him know I was coming over to see him, and I hitched a ride and was picked up by a man who asked where I was going and I told him the cross streets, while in the car he was patting me on my chest and legs very close to my genitalia and asked did I play sports because "I was built very firm" WTH? during the ride he asked me if I knew of any Gay Bars on the way and invited me to join him, at 13 I knew I could not enter a bar? When I arrived at my friend's house his older brother asked how did I get there so fast? I responded I hitched a ride with a guy who was looking for a Gay Bar (a fun place to drink?) the older brother said Gay Bar? are you stupid that guy was a queer! still unaware that some people in our society have deviant sexual desires for men and boys and men of the same sex I continued to hitchhike and found many unwanted male men's unwanted sexual advances. Yes some will excuse this behavior, and some will say this is different from Pedophile behavior, where do we draw the line? when a young male is reaching puberty what divides a sexual predator's actions for looking for a Mate or a Pedofiles Lust for Pre-puberty boys? Can you draw this line when we see the many in our community who are confused as to their own sexual identys and behave in strange sexual practices?

This is a very personal story and did not stop there, I purchased a 4-plex apartment and rented it to many people over the years. One tenant a single male moved into one rental unit, soon after he got a male roommate and I later found out they were a Gay Couple, OK different strokes. This came to a head when they would make out with the door and windows open and there was a Middle School next door and many children walked by. Then they inviting these young boys into their apartment while they kissed and made out on the couch for them to witness this behavior and it took me back to my own youth experience with Gay Men I was appalled, but I did not evict them as they had a lovers quarrel and one Shot the Other and that was the end for them in my complex.

Ok, so now you have heard my story and why many in the community reject our city flying the Pride Flag to support people's sorted sexual preferences and how their Religions have influenced their reactions. I can tell you I was Disgusted when the LBGQT group used a young boy of the age of 12 as a Prop who at 12 could not even understand what he was?

being groomed to say on their behalf. Appalling Behaiver but expected as they have a warped sense of what our youth should be expected to deal with, and Natalie Moser gave them her approval for using this young child as a Prop for their sexually deviant behavior.

For those who try to blur the line between Homosexuality and Pedofella and people's weird sexual desires, I would ask like Natalie Moser likes to say "Connect the Dots" Open your eyes as to why for Religious reasons and the sake of our Youth many if not most are Offended by our city raising a flag on their behalf. So now these city council members have added to the Division in our community and the public debates and the False Premace people will avoid our city and businesses, Just in Orange County alone there are 34 cities in the OC and only 7 of them display the Pride Flag on public property and I do not see them suffering from loss of business.

While I have grown tolerant of the LBGQT's rights to do what they do behind closed doors, I will Not Fly a Flag to Celebrate Them.

Public comments on this item focused on removal of the pride flag that has flown on city property for 2 years.

Agenda item 26. 23-172 was passed 4-3; with Kalmick, Moser and Bolton voting no. This directs the city attorney to take any legal action necessary to challenge SB 9 and SB 10 and the laws that permit ADU's.

Dear Honorable Mayor, Mayor Pro Tem, and City Council Members,

A frequent theme of many public speakers on both February 7th and 21st was the notion that certain individuals would "feel unsafe" in Huntington Beach if the Pride flag were not displayed on City properties. While I agree that the safety of all Huntington Beach residents and visitors is of paramount importance, I question the validity of protection from a flag or other similar symbol.

Perhaps a more viable and measurable guardian would be efforts by the City to take direct action to impact acts of hate and violence against individuals typically singled out because of race, religion, lifestyle, etc.

Below is a portion of the history of the Greater Huntington Beach Interfaith Council from their website. https://www.ghbicl.org/our-history

Attached is that document mentioned in paragraph 2, "A Declaration of Policy About Human Dignity".

One could argue that this document and its intentions foster more protection within our City that any flag or symbol could impart. It clearly demonstrates that Huntington Beach has already penned and committed to an "inclusiveness", even before the term was widely adopted.

I submit that no additional displays are necessary since they would only offer a "symbolic" gesture of safety, when in fact our stance has been clearly stated for the past 27 years.

I welcome your comments and invite you to share this document with others in the event that you have not previously viewed it.

I thank you all for serving our community.

DURING THE SUMMER OF 1996, A SERIES OF HATE CRIMES OCCURRED IN HUNTINGTON BEACH. FOR MEMBERS OF THE CITY COUNCIL AT THAT TIME, THIS WAS VERY DISTURBING, AND THEY DECIDED TO DO SOMETHING ABOUT IT.

UNDER THE LEADERSHIP OF SITTING MAYOR SHIRLEY DETTLOFF, AND SUPPORTED BY MAYOR PROTEM RALPH BAUER, THEY TOOK A MULTI-PRONGED APPROACH TO THE PROBLEM. ON MAY 6, 1996, THE CITY PRESENTED A "DECLARATION OF POLICY ABOUT HUMAN DIGNITY", WHICH SPOKE DIRECTLY TO THE COMMUNITY ABOUT THE INCLUSIVE NATURE OF THE CITIZENRY AND THE IMPORTANCE OF REPORTING HATE CRIMES.

MAYOR SHIRLEY DETTLOFF REMEMBERS AFTER HEARING REPORTS OF THE BEATING OF A NATIVE AMERICAN, AND HEARING THAT HUNTINGTON BEACH IS THE "CAPITAL OF SKINHEADS", AND OTHER HATE CRIMES, DETTLOFF REPORTS "AT THE TIME I WAS THE MAYOR... OF COURSE, I WAS HORRIFIED, AND IMMEDIATELY WENT TO RALPH AND SAID WITH OUR HISTORY WE SHOULD DO SOMETHING ABOUT IT. WE CONTACTED THE O.C. HUMAN RELATIONS GROUP, GOT TOGETHER WITH OUR POLICE CHIEF, AND PROCEEDED TO WRITE THE HUMAN DIGNITY STATEMENT. IT WAS BROUGHT BEFORE COUNCIL WITH A FULL AUDIENCE IN ATTENDANCE AND EVERY COUNCIL MEMBER SIGNED THE DOCUMENT. THIS HAS BEEN A TRADITION WITH EVERY COUNCIL. WE THEN DECIDED IF THIS WAS NOT JUST A PIECE OF PAPER THAT WE HAD TO HAVE CITIZENS COMMITTEES TO BACK IT UP AND TO KEEP UPDATED ON ANY ACTS THAT WERE COMMITTED AGAINST OUR CITIZENS BECAUSE OF RACE, RELIGION, SEXUAL PREFERENCE, COLOR. WE CREATED A GROUP THAT CONTINUES TODAY, THE HUMAN RELATIONS TASK FORCE AND THE GREATER HUNTINGTON BEACH INTERFAITH COUNCIL WHICH ARE STILL WORKING ON THESE ISSUES.

A Declaration of Policy About Human Dignity

by the Huntington Beach City Council

Huntington Beach is a city whose residents represent every walk of life, come from many nations, share varied lifestyles, and hold different religious beliefs. This diversity brings to our city a rich and varied cultural heritage. Our citizens honor and respect the diversity that exists in Huntington Beach. When acts of hate are committed against any citizen, it is considered an act against the entire community.

The Huntington Beach City Council declares that everyone should be treated with courtesy and respect, regardless of their racial background, their nation of origin, the religion they practice, their sexual orientation, gender or disability status. It is the right of all citizens to pursue their daily lives with the knowledge that they will not be physically harmed or verbally abused.

The Huntington Beach City Council states in the strongest terms that it will vigorously fight criminal activity known as "hate crime" with all of the resources at its disposal. A hate crime is any criminal or attempted criminal act which is motivated by the victim's race, ethnicity, religion, sexual orientation, gender or disability status. It may involve a verbal, written, or physical action that is intended to create emotional suffering, physical harm or property damage.

The City Council warns those who advocate or perpetrate hate not to test the community's resolve to oppose them. It is the city's stated policy to vigorously pursue a course of investigation, apprehension, prosecution, conviction, and incarceration of all those who participate in hate crimes.

In support of this declaration, the City Council sends these messages:

To the community we say, "Believe in the interdependence of all people. Participate at your places of worship and community meetings and lend your voice in opposing hate."

To the schools we say, "Continue your programs and curricula which promote respect towards those who are different. Call on resources of the city, the county, the state, and the nation as you engage in the educational process to battle hate."

To the parents we say, "Act as positive role models for your children by demonstrating tolerance towards those whose race, nationality, religion, sexual orientation, gender, or disability status may be different from yours. You are the most powerful influence on your children's behavior."

To the young people we say, "Educate yourself to the ways of the world and the lessons of history. Develop sensitivity toward the feelings of others. Thus, as you grow into adulthood and become society's leaders, you will be more effective in the fight to preserve man's humanity toward man."

We must all remember that a great war was fought in which millions of innocent people lost' their lives as a result of one of the greatest hate crimes in history. It is the martyrdom of those people who should serve to encourage all of us in the fight against hate. We must all become activists in this battle as a living memorial to those who lost their lives. Let us not forget the millions who came before, who but for the absence of strong opposition at an early time, would have lived long, happy, and productive lives.

Remember that silence and apathy are the greatest allies of those committing hate crime. If you are a victim or a witness of a hate crime, go to the nearest telephone, call 911, and say "I want to report a hate crime." With those seven words, you will instantly have as an ally the full resources of the city of Huntington Beach and the nearly 200,000 citizens of our city. You are not alone!

 Γ ogether, the city of Huntington Beach and its citizens will succeed in their efforts to permanently eliminate all hate crimes. The Huntington Beach City Council declares that it will not tolerate any hate crimes in our community.

The foregoing declaration of policy about Human dignity was unanimously adopted by the Huntington Beach City Council on May 6, 1996.




