WHEREAS, the City Council of Huntington Beach desires to modify the salary and certain benefits of the Elected City Treasurer; and

NOW, THEREFORE, the City Council of the City of Huntington Beach does hereby resolve as follows:

SECTION 1. The salary of the elected City Treasurer as reflected in the salary range contained in the Non-Associated Executive Management Salary Schedule "Exhibit 1B", attached hereto and incorporated herewith shall be at the control-point range of \$77.85 per hour. The City Treasurer shall be compensated based on thirty (30) hours per week.

SECTION 2. All other allowances and benefits will immediately match, continue to follow, and be updated according to agreed-upon Non-Associated Resolution modifications for appointed positions.

SECTION 3. Any existing provisions in conflict with the foregoing, whether by minute action or Resolution of the City Council is hereby repealed.
