## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUNTINGTON BEACH REVISING THE FEES FOR TOWING SERVICES AND GARAGE IMPOUNDS

WHEREAS, Huntington Beach Municipal Code Section 5.66.170 authorizes the City to set a maximum charge for police-directed towing services and garage impounds; and

On August 20, 2001, the City Council adopted Resolution No. 2001-52 which established maximum fees for police-directed towing services and garage impounds; and

On July 16, 2007, the City Council adopted Resolution No. 2007-44, which established revised maximum fees for police-directed towing services and garage impounds; and

On May 7, 2018, the City Council adopted Resolution No. 2018-21, which established revised maximum fees for police-directed towing services and garage impounds; and

The City's Tow Operators have requested an increase in the maximum fees charged for towing services and garage impounds based on an increase in their operating costs, such as fuel prices, employee health care costs, vehicle salvage costs, and other related expenses; and

The City Council wishes to revise the maximum charge for police-directed towing services and garage impounds based on the Tow Operators demonstration of an increase in their operating costs,

NOW, THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Huntington Beach that effective April 1, 2023, the maximum charges for police-directed towing services and garage impounds are as set forth on Exhibit A which is attached hereto and incorporated by this reference.

BE IT FURTHER RESOLVED that Resolutions 2001-52, 2007-44, and 2018-21 and all Supplemental Resolutions thereto, are hereby repealed.
