Upon my review of the proposed actions requested for Agenda Item 23-394 I offer the following observations and recommendations both Safety and prudent Systems Engineering discipline:

- The apparent scope of this proposed action seems to be limited to restoring interim electrical service to the Central Library. But with out adequate engineering analysis of the existing electrical design and the proposed rental support equipment compatibility would be both imprudent and fraught with risk for unintended further damage. Analysis should establish both compatibility and safety.
- When the analysis is complete, then you can achieve a much better solution which make the contractors ROM estimate OBE & gives the city staff a much better chance at cost containment with more precision.
- Recommendation for follow-on design solutions; should include Central Library upgrades to LED illumined sources for improved recurring operational cost savings and design simplification to possibly downsize over overall power requirement using LED technology.
