A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF HUNTINGTON BEACH AMENDING RESOLUTION NO. 2018-29
WHICH ESTABLISHED A CONSOLIDATED COMPREHENSIVE
CITYWIDE MASTER FEE AND CHARGES SCHEDULE
(SUPPLEMENTAL FEE RESOLUTION NO. 6)

WHEREAS, on June 4, 2018, Resolution No. 2018-29 was adopted, amending the Citywide fee for public access and use of certain City property; and

The City Council desires to revise a portion of the Fee Resolution to increase parking rates for the Huntington Beach Air Show for the three-day event period at the South Beach attended lots and the Main Promenade Parking Structure on an annual basis; and

The City Council desires to add a four-day Recreational Vehicle (RV) event camping pass that would be valid during the event period beginning after 10:00 a.m. on the Thursday preceding the event period through 10:00 a.m. on the Monday following the event period on an annual basis.

NOW, THEREFORE, the City Council of the City of Huntington Beach does hereby resolve as follows:

1. That the new charges set forth in **Exhibit "A"** and adopted by this Resolution shall be effective following the adoption of this Resolution, and continue thereafter. All other charges or fees set forth in Resolution No. 2018-29, as amended, shall remain in effect.




