AMENDMENT NO. 1 TO AGREEMENT BETWEEN THE CITY OF HUNTINGTON BEACH AND WITTMAN ENTERPRISES, LLC

THIS AMENDMENT is made and entered into by and between the CITY OF HUNTINGTON BEACH, a California municipal corporation, hereinafter referred to as "City," and WITTMAN ENTERPRISES, LLC, a limited liability company, hereinafter referred to as "Consultant."

WHEREAS, City and Consultant are parties to that certain agreement, dated October 5, 2015, entitled "Professional Services Contract Between The City of Huntington Beach and Wittman Enterprises, LLC for Billing Services for Emergency Paramedic and Ambulance Service," which agreement shall hereinafter be referred to as the "Agreement;" and

City and Consultant wish to amend the Original Agreement to extend the term of the Original Agreement and to increase the amount of compensation to be paid to Consultant,

NOW, THEREFORE, it is agreed by City and Consultant as follows:

ADDITIONAL COMPENSATION

In consideration of the services to be performed under the Original Agreement, City agrees to pay Consultant an additional sum not to exceed Three Hundred Ninety-Eight Thousand Six Hundred Seven Dollars (\$398,607.00). The additional sum shall be added to the original sum of Nine Hundred Ninety-Two Thousand Six Hundred Fifty-Two Dollars (992,652.00), for a new total contract amount not to exceed One Million Three Hundred Ninety-One Thousand Two Hundred Fifty-Nine Dollars (\$1,391,259.00).

2. EXTENSION OF TERM

The term of the Agreement is hereby extended for one (1) additional years. The Agreement shall now expire on October 5, 2019.

3. REAFFIRMATION

Except as specifically modified herein, all other terms and conditions of the Agreement shall remain in full force and effect.
