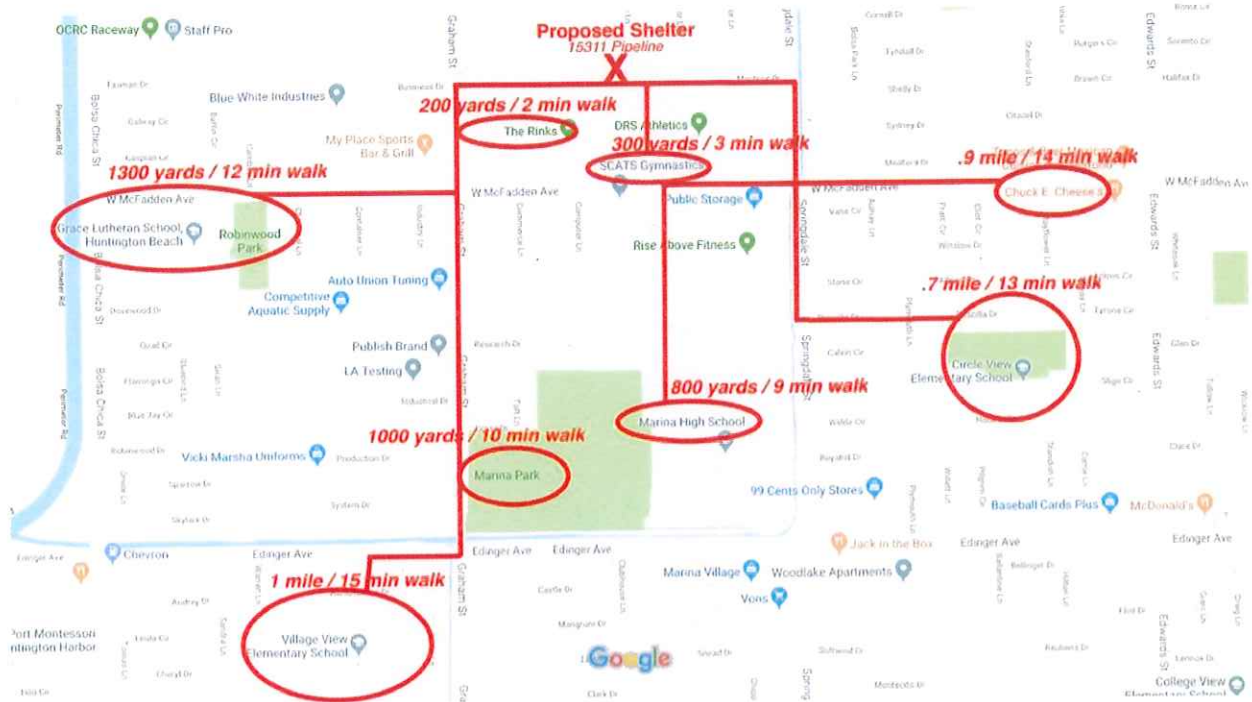

Regarding Proposed Homeless Shelter on Pipeline: It seems to us that the rush decision to put a homeless shelter in Huntington Beach is compromising the consideration of all properties and limiting the selection to existing warehouses available for lease or purchase. The location on Pipeline will bring crime and more vagrancy to this area of the city and will no doubt cause a loss in property values to those of us who own homes nearby. It is near schools, recreational facilities (SCATS & The Rlnks), and parks. We do not want an increase in homeless people hanging out in our parks and the former Railroad Easement. I no longer utilize Cascade Park in Westminster due to the vagrants hanging out there 24/7. While the homeless issue certainly needs to be addressed, a knee-jerk reaction is NOT in the best interest of Huntington Beach citizens, especially those of us who are parents, business owners, property owners and tax payers Let us remind you of the section from the Huntington Beach website about the city's General Plan: California State law (Government Code Section 65300) requires that each city prepare and adopt a comprehensive, long-term General Plan for its future development. State law permits cities to include optional elements in their General Plans, beyond the seven mandated elements, thereby providing local governments with the flexibility to address the specific needs and unique character of their jurisdiction. The General Plan is the fundamental policy document of the City of Huntington Beach. It provides the framework for management and utilization of the City's physical, economic and human resources. By providing a basis for rational decision-making, this document guides civic decisions regarding land use, the design and/or character of buildings and open spaces, the conservation of existing housing and the provision of new dwelling units, the provisions of supporting infrastructure and public services, the protection of environmental resources, the allocation of fiscal resources, and the protection of residents from natural and human-caused hazards. The General Plan acts to clarify and articulate the City's intentions with respect to the rights and expectations of the public, property owners, and prospective investors and business interests. Through the Plan, the City informs these groups of the community's goals, objectives and policies thereby communicating the expectations and responsibilities of all sectors in fulfilling the General Plan. In addition to the written goals and policies, the General Plan contains a Land Use Plan that is the prevailing determinate of land use in the City. The Zoning Maps and development standards function to
