Honorable Mayor Peterson and City Council Members:

Darren Sam of the City of Huntington Beach, Public Works, was kind enough to inform me that our neighborhood's Permit Parking matter would be on the April 15, 2019 Agenda for City Council's consideration and we are hoping City Council approves this item. As the April 15, 2019 Agenda is not yet posted, I do not know which specific agenda item to refer you to; however, I wanted to provide you details and pictures in advance of the posting so that you may review the dire issues our neighborhood has been dealing with. Our neighbors are petitioning for parking permits and applicable signage in our neighborhood for both safety, cleanliness, and peaceful enjoyment of the residents, many of which are quite elderly and some residents which have known disabilities. Please find enclosed two signed petitions for permits voted on and approved for the following streets: Tucana Drive, Taurus Lane, and a portion of Rook Drive.

It is pertinent to note that we spoke with each resident, provided them with a copy of Chapter 10.42 PERMIT PARKING DISTRICTS and informed them that there would be a fee with this process as well as signs posted on the street potentially in front of their home. Each and every neighbor we spoke with was 100% in support of this process. The petition includes the following terms:

Days of the week - 7 days a week

Effective hours - 10:00 PM - 7:00 AM

Streets Impacted — Tucana Drive, Taurus Lane, and a portion of Rook Drive


Reasons for Implementation - Safety and Security, Noise Abatement, Trash Abatement, Limited Parking Availability in Neighborhood, Dangerous Parking by Non-Residents (on curve entering neighborhood), and Observed Drug Deals from Persons Outside of Neighborhood. Please kindly note that the weekends have been extremely busy (perhaps due to Spring Break) and we anticipate the summer will even be worse. The cars are loud, especially on Friday and Saturday nights. Music is blaring and trash, including beer cans and alcohol bottles are being left. Vomit is frequently present as well lots of garbage. Many elderly and disabled people live on our street and are frequently woken up by these apartment dwellers and their friends. I am frequently picking up trash and broken alcohol bottles, as are my neighbors. In addition, I have written the manager multiple times at the Regency

Palms as I was told by individuals parking on our street that the Manager instructed them to park there. I was also informed that management at the Regency Palms knowingly rents to four or more people in two bedrooms and does not provide enough parking slots.

Also, please see the Huntington Beach Community Forum page. I posted a complaint and several residents and neighbors made relevant comments. In fact, one neighbor complained about the bottles of urine left and many Regency Palms tenants complained about their parking issue and confirmed that this should not be our neighborhood's problem.
