

To Whom it May Concern: Let me start by mentioning that the time of the open house wasn't well thought out, many families couldn't attend because it's currently sports season (heard this from almost every parent on my daughters soccer team). Before I sent this email, I wanted to attend the open house so I could draw my own decision. While the open house was a courteous thing to do for the residents, I felt that it was a way to deliver a pipe dream. Many questions/concerns couldn't be answered, I'll list them here: 1. It was mentioned that the site would be purchased, and that there may be a tax increase. If purchased this goes from temporary to forever? 2. A lot of mention that property values won't decrease. After much research I've found that when located within about a 2 mile radius of a homeless shelter property values decrease 10-12 percent. While I could accept a down economy making my home less valuable, I refuse to sit back and not say a word when something like this can be catastrophic to a lot of residents futures. 3. If this passes/built and there is a decrease in property value, will homes be reassessed for lower a property tax rate? It's a very valid concern, I know I'm currently paying almost \$8000 per year. 4. There apparently is a plan that when these residents want to leave, they are taken to the octa station. What guarantee can you give that they will indeed be getting on a bus to head out to do something productive? Do the residents that leave have to go through a process every time they return? How can the city guarantee that once dropped off at a bus station they will be doing productive things? Through my research I have found that our nearby cities that have a shelter location haven't been too successful with the rehabilitation of their residents. 5. How can the city guarantee that homeless won't congregate near this area? Rules are broken every single day, I find it very shocking that the answer to this question is "nobody will loiter". The only other answer I have heard is that there will be an increase in officer patrol, which I feel had to be said because the city knows how this is going to go. A nearby park had its wooden overhang burned down by the homeless, and it has yet to be repaired. 6. If you assess the location, there are many businesses that are kid oriented. I've spoke with many people who have said they won't be taking their children to these locations if this idea passes. What action will the city be taking in helping with the loss of revenue to these businesses? 7. There has been a lot of talk saying that this facility will be 'secure' and that there will be fencing everywhere. Has anyone at all from the

Before we even knew of the possibility of a shelter near us, she was talking about how she might have a place close to Marina HS. We thought it was an apartment, never imagined it being a shelter and we all started worrying. Now hearing a shelter may be still close by Marina HS we are worrying again. You see, our family is afraid her Mom will show up daily to Marina if she would be transfered to this location. My Step Daughter is now doing so well in school but, stresses about this. We also worry about her Mothers choice of friends shes made while in these shelters. We thought we were in the clear after the last location was rejected due to so many making it clear it was too close to Marina. This new location is only a few blocks away. We did have a chance to drive by it on Friday. It literally is a 2 minute walk. Hearing this again, we are worried again. We go to Santa Ana monthly to visit her Mom. We see the homeless in the streets, parks and businesses. We see the alcoholics, drug addicts, beggers, mentally Ill and we also see nothing can be done unless they have committed a crime. We dont want that so close to our schools, homes or community. Again, my step daughter and our family is personally effected by this. This location being so close to Marina is not a good solution. My name is Lisa DeLuccio-Kavalesky. I am writing on behalf of myself, my husband Mark Kavalesky and our children, Katheryn Kavalesky, Jamey Kavalesky and Lukas DeLuccio.

My husband and I attended the Open House last Saturday and came away with some information, but still scratching my head. I am all for helping out the homeless who want the help. However, I am not for that help to be located anywhere near Marina High School.

Two weeks ago we all breathed a sign of relief when the first location of Research Dr was rejected. We all were happy you heard our voice. Which makes no sense why you move it 2 blocks away from the original location, still located 2.5 minute walk from the shelter to Marina, not to mention multiple other schools and children's facilities.

Having said all that. This is a very personal issue for my family. You see I have a 17 year old step daughter who attends Marina, is a Junior this year. She has found herself at this school is happy. She went from a D-F student, no self confidence to a flourishing young adult since I married her Dad. Prior to this she lived with her Mom who was verbally and mentally abusive. Her Mom has been homeless in Santa Ana for 3 years now. She started out in Victorville, and was transferred to Santa ana. During her time in Santa Ana, she has lived in 3 "90 day shelters:" Never getting the help they claim they have. Her Mother is Manic Bi Polar, on and off medication and has not worked in over 10 years. We hear monthly how she will be getting an apartment soon, or a job soon. None of this ever happens, yet she continues to live in these 90 day facilities, this last facility has been almost a year.

End of last year her Mother started telling us of a place that might open up soon in Huntington Beach, near Marina High School. We thought it was an apartment, not a homeless shelter. Hearing about the potential homeless shelter late March. We put 2 and 2 together and realize now what she was talking about. She wanted to be transferred to the location so she could be closer to her daughter and next year her son will be at Stacey which is about a 10-15 minute walk from Pipeline. My step daughter has been very nervous about this, as are we. If she were to be transferred or accepted she would show up daily at Marina or surrounding locations looking for my step daughter. We know her, know how she is and understand she would do anything to try to getting the surrounding locations.

Please understand, we don't keep the kids from their Mom. We, infact take them monthly to Santa Ana to meet their Mother for dinner. She's always welcome to call them. But we have a buffer right now since she is not close by and no way to get to them other than walking or the bus and from Santa Ana that's a far way to come from.

We understand what we were told that, only the homeless will be accepted to this shelter. We also understand this to be true about the Victorville location, she was not a resident, she was passing through the city when she had an episode and the police placed her at that location there. She was only living there 90 days, was then transferred to 1of3 90day facilities" here in Santa Ana. We also understand the preferred location is off Gothard, which we couldn't agree more and it makes more sense to have it in that location centralized to HB and the police station. We understand the struggles of finding a location in that area. However we know that Pipeline is not the correct location and cannot stress enough to please continue your search in the location that would be optimal for the city and police.

Never in my life did I want to really know so much about how homeless facilities are run, but we've learned alot in these past 3 years from my husbands ex wife. We understand that a 90 day facilitie is not really just 90 days and can be expanded as long as the person is not causing problems. We know they are not prisoners and can come and go from 7am to 10pm 7 days a week. We understand during these times they are supposed to be out looking for work, doctors appointments, etc. We also know this does not always happen. We see how Santa Ana looks, homeless passed out on lawns of public buildings, loitering at grocery stores, liquor stores or just on side walks. We've seen them drunk, using drugs, being arrested, screaming, defecating, fighting, having sex, robbing, causing crime, etc all in the day time and in the public eye. Some things as you know cannot be controlled, do you want this near Marina High School, Vons, .99 cents store, 7-11 and Jack in the box just the closest businesses near Pipeline? We understand the rules of the shelter she is at, which are the same as the one's outlined you've given to the public for Pipeline. We know they are not shuttled to and from locations of where they want to go during the day 90 plus people can not be catered to in that way. We know they are given bus passes and free Lyft rides to get to their destinations during the times they are allowed out or simply can walk. I feel you are giving the public who does not know this a false sense of security thinking they are under the watchful eye 24/7 when that is not the truth.

Having said all that, we'd like to thank you for allowing the public to voice their opinion so you may make a valid decision to not only the homeless needs, but to the homeowners, business owners, students and parents. Again, we cannot stress enough to please do not have a shelter located anywhere near Marina High School for our personal needs. My step daughter is scared her Mom will try to find her daily, interrupt her school and friends. We would take legal action if needed, however we would like for your to scrap Pipeline and find a different location all together.

First, I feel very strongly about keeping a shelter away from our young children and young adults. Opening one so close to schools enables a chance for lingering close to the schools. Opposition to homeless shelter on Pipeline Lane (Letter Attached) City Council, I am writing this letter in response to the proposed homeless shelter that is being considered at 15311 Pipelane Lane, HB. I would like to put on record that I deeply oppose the location of the shelter. I attended the open house at the library on 04/13/19 and unfortunately it appeared nothing more than a fluff show to promote how safe and helpful this shelter will be. City Officials, Council and other attendees, in robotic form, repeated the same rhetoric praising what a great addition this will be to our City. Although I realize that the demands by Judge Carter are unreasonable, I believe the City is rushing this decision and not thinking it through clearly. Some facts that the City must take more seriously: 1. Proximity to children. The proximity to Marina High School, Grace Lutheran School, Circle View Elementary, all of which are less than a ¾ mile from the shelter. Scats Gymnastics and The Rinks are the closest. The Rinks and Scats are both .3 miles (or approx. 1760 ft) from the shelter. These schools and businesses cater to children! For that reason alone, this location is unacceptable! 2. Home Values. Realtor.com estimates that homeless shelters cause nearby neighborhoods to lose up to 12% in equity. It's the #4 reason potential buyers would have difficulty moving to the neighborhood. By the way, that equates to over \$90,000 for my home. That is \$90,000 that I won't be able to use for retirement (I'm 61 years old) and/or leave for my children. 3. Saftey. Although it is said that there will be security guards on site 24/7, this will not be enough to offset violence or drugs. It is well know that our Police Officers are already spread thin. They oftentimes struggle to respond quickly to every call that goes out in the City. This ties their hands and causes them to only be able to be reactive rather than proactive to crime. If someone does leave the shelter in a non-acceptable way, they will quickly have access to children and homes. Additionally, our homeless task force Officers are made up of two men who work until the early afternoon hours on weekdays. This is not enough. 4. Local Businesses. Businesses in the industrials are not for this either. Are we going to allow the loss of the vital taxes that business revenue generates? No doubt, some will leave the area for a location that doesn't have the same riff - raff associated with homelessness. 5. Lawsuits. If the City erects this shelter in close proximity to children and something happens, the City will undoubtedly be sued. I've heard people already threatening this action should something happen.
