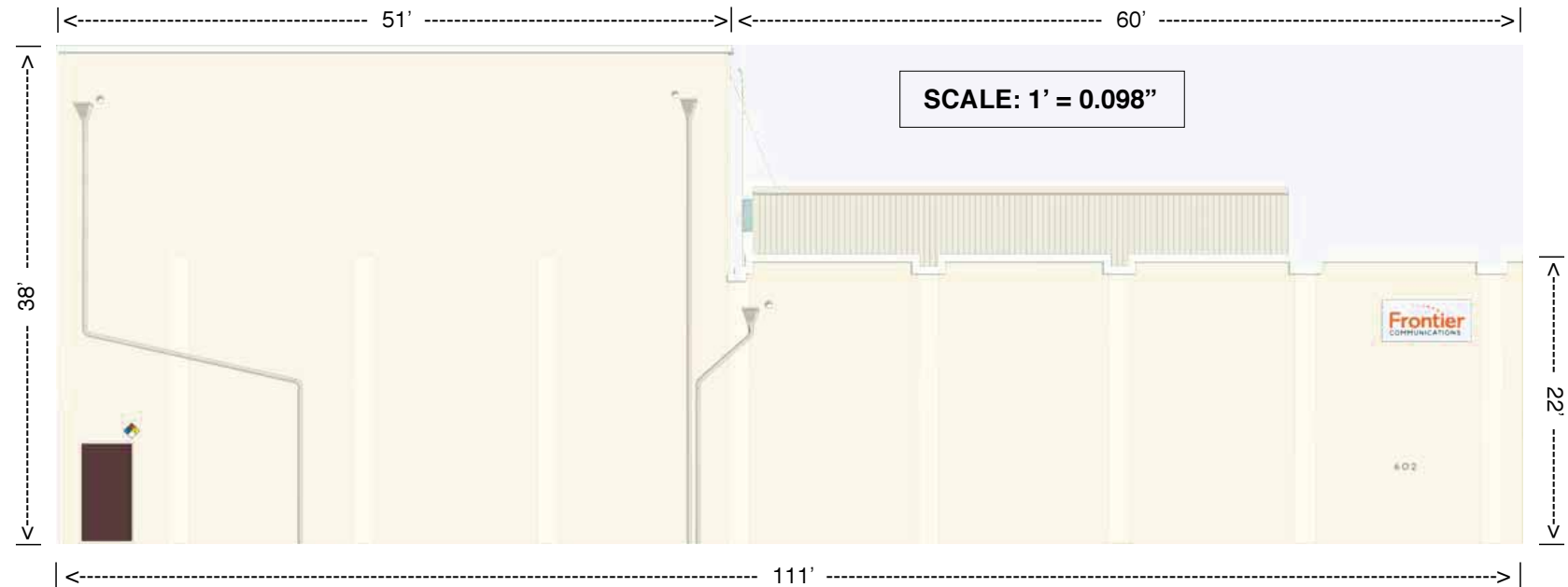
FRONTIER MURAL PROJECT NARRATIVE

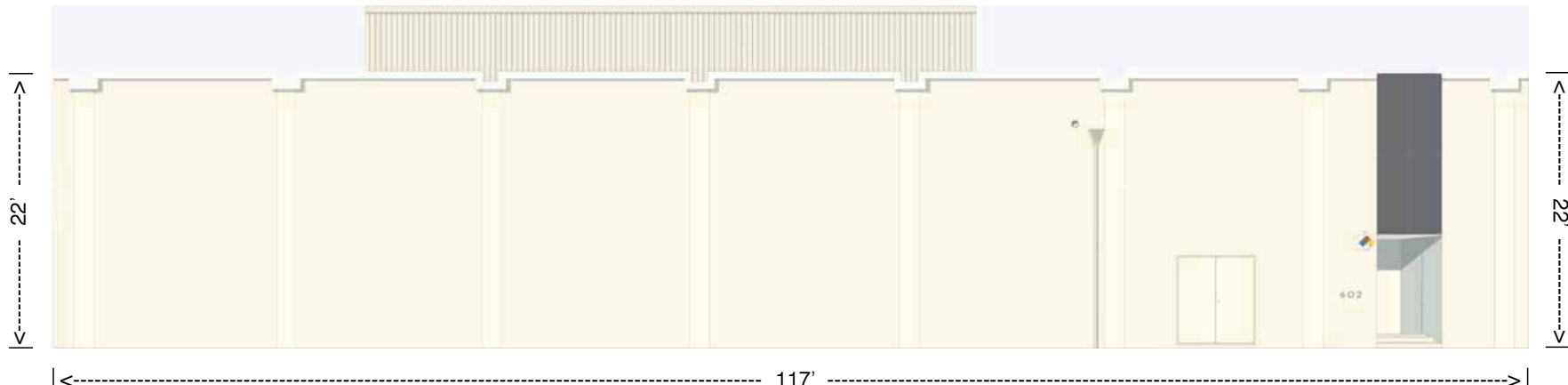
To the East of the building are residential homes, to the South is the Huntington Beach Art Center, across the street to the West is the Main Street Branch Library and to the North are residential homes.

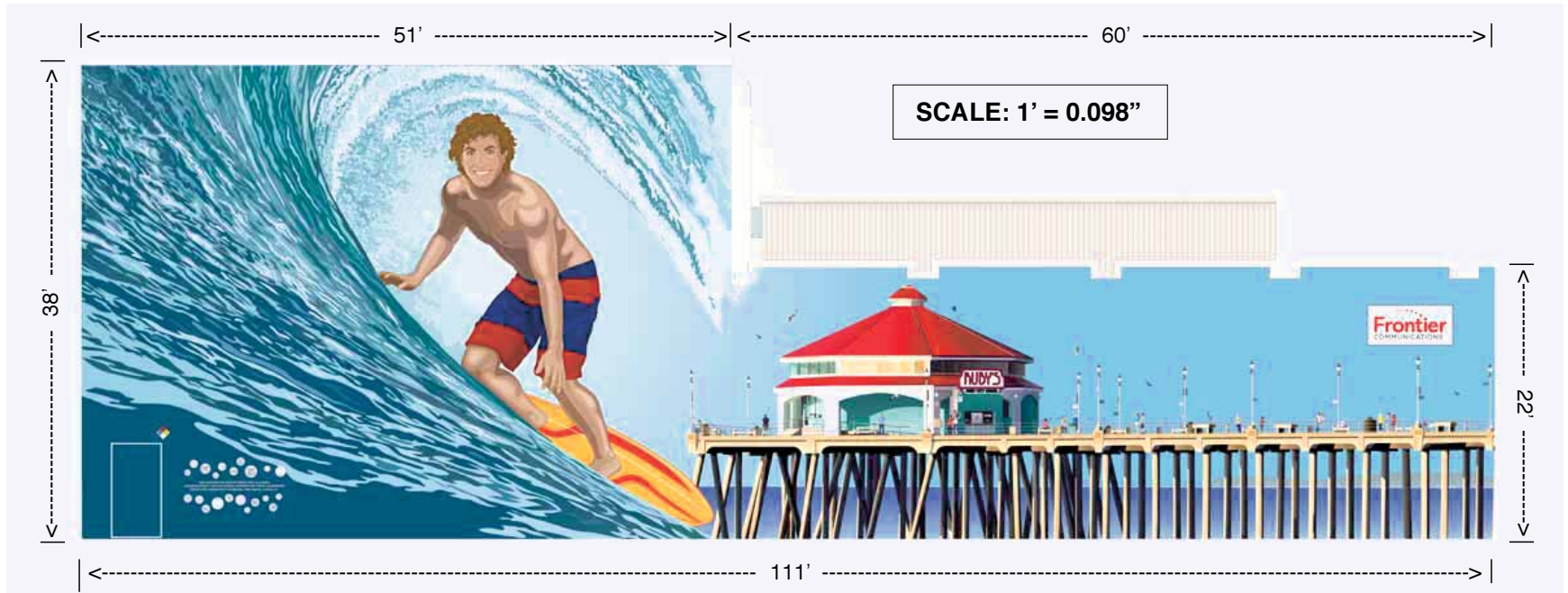


MAIN STREET ELEVATION

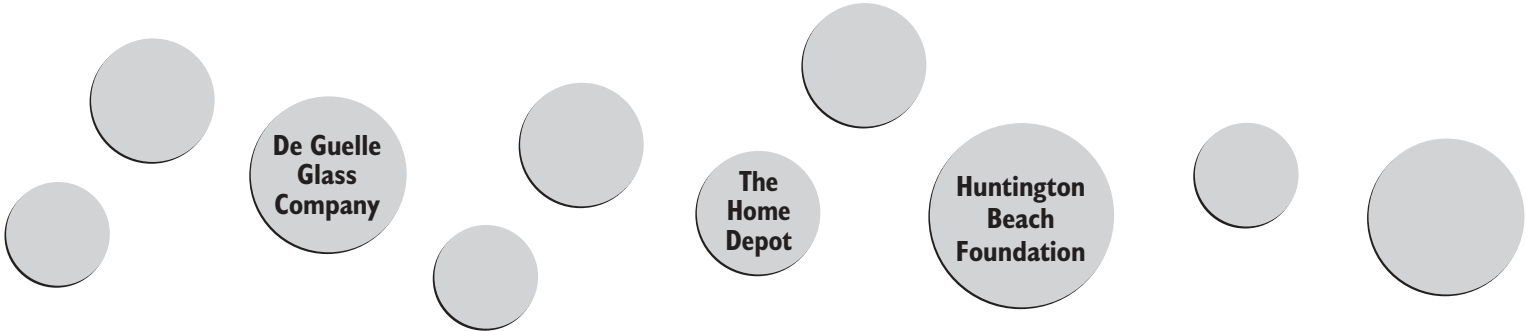

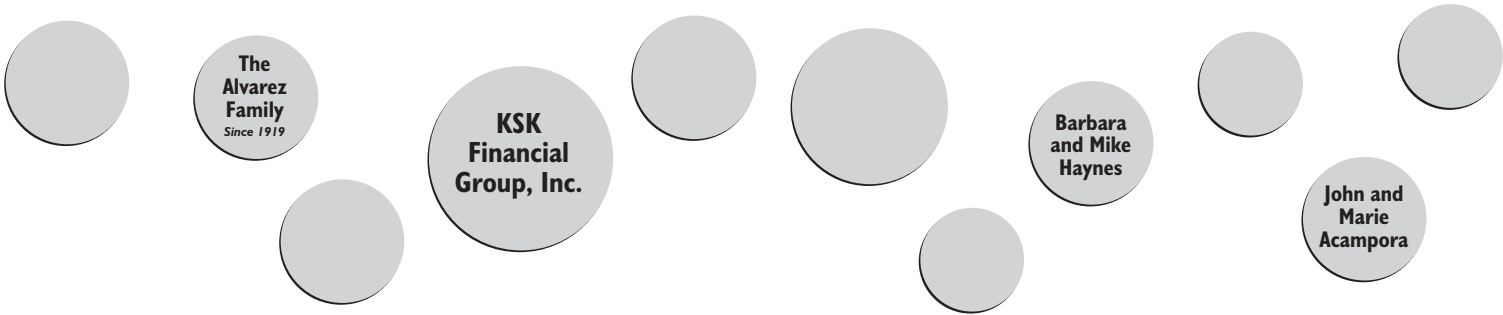
ACACIA AVENUE ELEVATION
