### WHERE TO USE

Protection for Wood, Vinyl, Aluminum, Fiber Cement Siding, Metals, Brick, Masonry, Stucco, Doors, Windows, Trim, Shutters, Steel, Fences, Garage Doors, Outdoor Furniture, Railing and Wrought Iron.

### **PREPARATION & PRIME**

Use on properly prepared and cleaned coated and uncoated Exterior surfaces. Countersink nailheads, fill and sand smooth. Remove rust, loose or peeling paint. Repair imperfections and sand smooth. Wash off dirt, grease and chalk with detergent and/or powerwash. Remove mildew stains with a mildew stain removing product. Clean and sand new or weathered wood. Scuff sand or degloss smooth or glossy surfaces. Scuff sand or etch metals. Rinse and allow to dry. Caulk windows, doors and other openings. Allow new stucco, plaster and masonry to cure for 30 days before painting. Use BEHR MARQUEE Paint as a primer for repaired or uncoated surfaces, including woods that contain tannins and heavily stained areas (two primer coats required for redwood and cedar) . Lock in stains with the first primer coat; if necessary, apply a second primer coat of BEHR MARQUEE. On heavy stains and woods that contain tannins, allow 12-16 hours of dry time between coats. For drastic color changes or when applying deep colors denoted with a dagger (†) on the color chip, apply a tinted primer coat of BEHR MARQUEE, if needed.

#### **APPLICATION**

Apply product on dry substrates when air and surface temperatures are between  $35^{\circ}-90^{\circ}$  F ( $2^{\circ}-32^{\circ}$  C) and will remain between  $35^{\circ}-90^{\circ}$  F ( $2^{\circ}-32^{\circ}$  C) for at least 4 hours after applying. Allow paint film to dry for at

### WHERE TO USE

Over properly prepared uncoated and previously painted Interior and Exterior surfaces. Ideal for Drywall, Masonry Stucco, Galvanized Metal, Vinyl, Aluminum, Wood, Concrete and on glossy surfaces or oil based paint.

### PREPARATION

All surfaces should be properly prepared and cleaned. Remove loose paint, wash off chalk, dirt, and grease with detergent, rinse and allow to dry. Remove mildew stains with a mildew stain removing product. Scuff sand glossy and metal surfaces and repair imperfections. Remove all dust with a damp cloth, allow to dry. Allow masonry/concrete surface to cure for 30 days before applying. All masonry surfaces must have a pH of 13.0 or less prior to coating. FOR EXTERIOR SURFACES: For new or uncoated wood, use a product such as BEHR PREMIUM<sup>®</sup> No. 63 All-In-One Wood Cleaner. Etch galvanized metal with a product such as BEHR PREMIUM No. 991 Concrete & Masonry Cleaner & Etcher.

### **APPLICATION**

Apply when air and surface temperatures are between 35-90° F (10-32° C). Use a high quality 3/8-1/2" nap roller cover, nylon/polyester brush or an airless sprayer (.015-.021" spray tip, 60 mesh filter). Stir primer occasionally. Do not thin if using a roller or brush; however, if using a sprayer and thinning is required, thin with water at a rate of no more than 1/2 pint per gallon. Two coats may be needed over stains and woods that contain tannins. Spot prime patched areas first, follow with a complete primer coat. Topcoat within 30 days. Bright or deep colors require a tinted primer. Have primer tinted close to topcoat color with no more than 4 ounces of colorant per gallon. † On stained surfaces, topcoat in 4 hours, for heavy stains, topcoat in 16 hours.
