Water Rates Background

- Current Rate Structure
 - Uniform commodity rate
 - Meter fee based on meter size or number of dwelling units
 - Capital Charge Based on meter size or number of dwelling units
- Resolution 2018-20 sets the annual adjustment formulas for commodity rates.
 - Commodity rate adjusted based on basin pumping percentage (BPP), replenishment assessment (RA) and imported water rate
 - Increasing from \$2.10 to \$2.16 per billing unit (748 gallons)
- Resolution 2018-17 establishes formulas for the Water Meter Fee and Capital Charge adjustments
 - Meter fee adjusted based on percentage change in CPI
- Capital Charge reintroduced in 2018 to fund Water Infrastructure Projects in the City Council approved Water Master Plan
 - Set at \$3.00. Increases by \$0.50 in 2020 and \$0.50 in 2022.

Proposed Monthly Water Meter Rate

- For Operations and Maintenance of the \$1.4 billion water system
- Adjusted by the Percentage Change of the Consumer Price Index-Urban Los Angeles-Orange-Riverside counties established by the U.S. Bureau of Labor Statistics and available after November 1 of each year through 2023.
- Based on meter size for all customer classes; Multifamily
 Residential Accounts no longer charged based on units attached to meter
- Increase by \$1.00 on July 1, 2019, 2020 and 2021

Proposed Methodology based Meter Size Only; No Longer Based on Equivalent Dwelling Units for Multifamily Residential.

Number of units on MFR are examples, actual number varies by customer

Capital Charge

- No Change recommended in the Capital Charge rate
- Approved by City Council in 2018
- Capital to address ongoing capital infrastructure needs (wells, pipelines, etc.)
- Set at \$3.00
- As previously approved, Capital Charge to be Adjusted by \$0.50 in 2020 and 2022
- Proposed Methodology to be Based on Meter Size for All Customer Categories

Sewer Rates

- Sewer rates based on customer categories and adjusted annually by change in CPI.
- Recommended reduction of \$1.00 per month for SFR customers (prorated for other customer classes)
- Sewer Lateral Program introduced in 2008. Originally had demand of \$2 million. Demand stabilized between \$300,000 to \$450,000 annually; savings to be passed on to customers
- Development Fees used to help offset costs Sewer Lift Station replacements



Proposition 218 Procedures

- All residents and property owners are mailed a protest hearing notice 45 days before the public hearing.
- City Council holds public hearing on the proposed adjustment(s).
- If 50% + 1 of property owners/residents mail in protests, adjustment(s) cannot be adopted.
- Requires two-thirds of Council to support
- Staff recommends City Council vote to approve the resolutions for rate adjustments.

Recommended Actions

- Adopt Resolution 2019-30, reducing sewer service user charges.
- Adopt Resolution 2019-31, adjusting water meter rates, including a capital surcharge.
- Adopt Resolution 2019-32, readopting the City's water commodity rate.
