My name is Issac Sanchez, I have lived off of Slater for about 12 years now. I live on the corner of Slater and Van Buren Lane, and when we first moved in there was plenty of parking off Slater Ave. That was later changed to build a sidewalk, which leaves us to park strictly on Van Buren Lane. I noticed that we got the letter concerning Permit Parking on Marken Lane, and I am all for it. However, that will have a huge effect on parking situation across the street on Van Buren Lane. As of right now, the parking situation is atrocious. The neighbors are very, for lack of a better word, annoying. Everyone that lives around this area has multiple vehicles, more than 4 usually. And as you can see from the pictures I have attached, people here think its better to leave huge gaps between parking spaces making it difficult to find parking. This isn't just on Van Buren Lane, this is all around that entire area. Van Buren Lane, Michael Drive, Opal Circle, and Jefferson Lane.

Marken Lane is sometimes the only place some of us can park when coming home late, so when I read this letter I feared that I would no longer be able to park my car on Marken Lane and then walk across the street to my house. People on Michael Drive have already started making it clear that they do not appreciate us parking in front of their homes, even though it is perfectly legal to do so. I have had multiple confrontations with the surrounding neighbors about such issue. So sometimes its best to park on Marken Lane, but the people around their don't appreciate that either. I would like to suggest that you make the surrounding neighborhood streets permit parking only as well, or at least come paint parking space lines on streets mentioned earlier. The surrounding streets are mostly filled with vehicles that are owned but hardly ever move because people own too many cars and only use one. I have reported vehicles for not moving for weeks at a time. I would like to Thank You for your time.

Dear Huntington Beach City Council and City Leaders,

My name is Bin Huang, a Huntington Beach resident living in this proposed Residential Permit Parking District for more than 11 years. Our community and I would like to thank you for accepting our petition and helping us along the process.

In the past years, our community observed that street parking issue has been getting worse and worse. More and more "commuter" vehicles from outside this area are parking in this district caused a lot of issues, most of them are:

1. Reduces parking space for resident and their visitors
2. Noise in the midnight as more "commuter" vehicles arriving after midnight, with loud music and exhaust
3. Frequently, garbage collection blocked by those vehicles parked next to it, and garbage can got hit by those vehicles caused damage
4. More trash on the street and sidewalk
5. Jacked up pick-ups and SUVs park at the edge of driveway exit, blocking the sight of driver who are backing up vehicles out of driveway, creates safety issue for residents
6. Drug dealing close to the intersection of Marken Lane and Holland Drive
7. Store vehicles, some commuter vehicles parked on the street for server days without moving. Recently, we had one disabled car parked on the street for more than 17 days, even after getting two street swiping parking tickets
