AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF HUNTINGTON BEACH AND GO LIVE TECHNOLOGY, INC. FOR

AS NEEDED INFORMATION TECHNOLOGY PROJECT MANAGEMENT SERVICES

THIS AMENDMENT is made and entered into by and between the CITY OF HUNTINGTON BEACH, a California municipal corporation, hereinafter referred to as "City," and GO LIVE TECHNOLOGY, INC., a California corporation, hereinafter referred to as "Consultant."

WHEREAS, City and Consultant are parties to that certain agreement, dated June 5, 2017, entitled "Professional Services Agreement Between The City of Huntington Beach and Go Live Technology, Inc. For As Needed Information Technology Project Management Services," which agreement shall hereinafter be referred to as the "Original Agreement;" and

Go Live Technology was retained in 2017 to work on multiple complex software implementation projects including the Enterprise Cashiering, Utility Billing, and Enterprise Land Management initiatives. To improve customer service features and functionality for the new Utility Billing system, Go Live Technology was assigned to provide greater assistance for the Utility Billing project, necessitating additional compensation to Consultant to continue project management services for the Enterprise Land Management project.

NOW. THEREFORE, it is agreed by City and Consultant as follows:

1. ADDITIONAL COMPENSATION

City agrees to pay Consultant and Consultant agrees to be paid an additional not to exceed amount of Ninety-six Thousand Dollars (\$96,000.00), for a total not to exceed amount of Two Hundred Ninety-six Thousand Dollars (296,000.00)...

2. REAFFIRMATION

Except as specifically modified herein, all other terms and conditions of the Agreement shall remain in full force and effect.
