AMENDMENT NO. 2 TO AGREEMENT BETWEEN THE CITY OF HUNTINGTON BEACH AND COMMUNITY SERVICES PROGRAM, INC.

WHEREAS, City and Consultant are parties to that certain agreement, dated

the "Original Agreement"; and

Hundred Forty Two Thousand Five Hundred Eighty One Dollars (\$242,581), for a new total not to exceed Three Hundred and Five Thousand Twenty Eight Dollars (\$305,028).
