Good Morning -

Thank you for doing everything you are doing to reopen our beaches. I am a long time resident of Sunset Beach, and I work for the company that owns the Paséa Hotel & Spa, and our beaches need to be open.

I would like to provide a couple of observations regarding the beach closure:

- 1. Due to the beach closures, bike path closures and sidewalk closures, we noticed yesterday that this alarmingly forced hordes of people on to the bike lane adjacent to Pacific Coast highway. This included, bikers, walkers, runners, and people walking their dogs. This was especially concerning along the stretch of Highway between Beach Boulevard and Brookhurst where the ice plant meets the asphalt and the speed limit increases. Bikers were riding outside of the white line to pass people walking or running, and then slightly going in to the lane of traffic where cars had to veer over to the other lane or put on their brakes, it was entirely unsafe and is worse of a safety issue than allowing people to ride on the bike path.
- 2. I have a vacation ownership in Hawaii and I follow a lot of the Hawaiian news. As the beaches are iconic to Southern California it is even more so in Hawaii. The government there has closed the beaches to lounging (towels, chairs, etcetera), but allows other activities such as running or walking on the sand, surfing, swimming, etcetera. I don't think they have the bike paths like we do, but if they did, I'm sure riding bikes would be allowed as well. If this sort of thing was done, I think it would be the perfect compromise until we come through this pandemic.
