
Subject: 3rd block street closure


The third block of Main Street closure is detrimental to the vitality of the businesses that are not restaurants on this block. We have had several promotions and marketing events and nothing has worked to bring the business we've lost back. As you know, each block of Main Street is built completely differently. The third block of Main Street relies on vehicular traffic to survive. We need these roadblocks that make us look like we are out of business removed immediately. There are now three streets in down town that have outside street dining and the street is open to vehicles. The same is also being done on Main Street in Garden Grove, Main Street in Seal beach, and in Belmont shore in Long Beach. I have attached photos of these areas for your reference to this email. Please vote tonight to open Main Street third block to vehicular traffic immediately. Our future depends on it. There is no reason this street should be closed to cars. In downtown 5th street is open and Cruisers has street dining with cars driving by. On the 1st block of Main Wahoos has street dining and the street is open. On Walnut Gallagher's & Boat House are dining in the street and cars are driving through. Also, please note that the kiosks across the street from my business are not all being utilized. At least four of them have not been open one time the entire summer. These can definitely be relocated to allow for more outside dining on that side of the street as well as using the fire zone. 



