Members of the City's boards, commissions, committees, or task forces serve four-year terms with a two-term limit. Appointment to a City advisory body is at the City Council's discretion. In addition, all appointed members must be United States citizens, residents of Huntington Beach during the appointment process and term, and may not hold more than one advisory group membership at the same time. Specific definitions of the role and purpose of these advisory groups are defined in Chapter 2.100 (Operating Policy for Boards and Commissions) of the City's Municipal Code.

A BOARD is a body of members appointed by the City Council pursuant to City Charter Section 405 to serve in a continuing advisory capacity to the City Council.

A COMMISSION is a body of members appointed by the City Council pursuant to City Charter Section 405 that may have decision-making authority over those activities delegated to them by the City Council.

A COMMITTEE is a body of members appointed by the City Council pursuant to City Charter Section 405 on an ad hoc basis to advise the City Council on a particular matter.

To assist you in selecting a citizen body that would be compatible with your interests and qualifications, a description of each body is available on the City's Boards and Commissions page.

- · All Council appointed commission, board, and committee members are required bi-annually to take harassment training and two hours of ethics training.
- You are applying for a public position. As such, the information provided in your application is a public record and cannot be kept confidential.
- Applicants must be U.S. citizens, residents during the appointment process and term, and may not hold more than one
