Calls for Service - Response Times

Priority 1 Response Time measures the Department's ability to get officers to the scene of high priority, in progress incidents

- · HBPD Average: 4 minutes
- Seattle: 7; Los Angeles: 5.7; Miami: 8;
 Austin: 9; Anaheim: 7.5 minutes





Investigation Clearance Rate

Clearance rate measurements allow us to gauge the efficiency & responsiveness of our department, & assists in determining organizational structure and deployment levels.

Injury Traffic Collisions

Traffic collisions resulting in injury or death have a significant impact on our community. This data drives our resources & allows for targeted outreach & education. Data is also leveraged for OTS grant funding.

DUI Related Traffic Collisions

DUI related collisions require a standalone focus & dedication by personnel & resources. Data is used to develop education & proactive enforcement measures.

Homeless Calls for Service

We have dedicated significant resources to handle homeless related calls for service & support. Data serves as a barometer to measure the efficacy of policing efforts.

Part 1 Crime - Regional Comparison

Regionally, cities are seeing an increase in Part 1
Violent Crime & a decrease in Part 1 Property Crime:

- Violent: Increased between 12%-63%
- Property: Decrease between 8%-36%
