Dear Mayor Carr and City Council Members,

I have been perplexed about how to solve the selection stalemate on the seventh Council Member that would eliminate the choice between Jeff Morin and Rhonda Bolton. In consultation with another Southeast Huntington Beach leader, I would like to now recommend the following since neither side of the 3-3 split was prepared to give in to an appointment that would last until 2024. A subsidiary goal of my recommendation is to avoid a costly and tumultuous special election in the middle of a formidable set of civic challenges that includes a resurgent COVID-19 pandemic virus. I would set aside both finalists (Jeff Morin and Rhonda Bolton) and other new and untested candidates (who all can run on their merits in the 2022 local election), and appoint a replacement Council Member from the ranks of our former mayors. This option was chosen in the wake of Council Member Dave Garofalo's resignation in 2001, and former mayor Grace Winchell was appointed for the remainder of the term in 2002. Winchell had no intention of running for office again. Naturally, the Council should consider a replacement that is up on current issues and possesses the leadership skills and drive to guide the Council forward. Ideally, the Council may choose to consider a former mayor who actually applied to be the appointed replacement for Tito Ortiz and a former mayor whose constructive reputation and community ties would be a huge plus.

I would like to propose that former mayor and longtime Council member Jill Hardy be selected as an interim appointment. The term could either be the remainder of the Tito Ortiz term (until 2024) or the balance of a term ending with the 2022 election. Since Jill Hardy was expected to seek a new Council term in 2022, and since she is eminently qualified (having worked with four of the current Council previously), it would be a perfect fit that would save over a million dollars for a special election so close to 2022. Jill Hardy is well known to the citizenry and is respected by

almost all residents. She is fair and honest and has shown she can work well with her Council colleagues.

This decision would not deprive any of the serious former hopefuls who applied to fill the Council vacancy from the ability to run and serve in 2022. None of the other finalists (especially the balance of the 18 not making the current standoff selection) would have been picked in this process anyway. The City Council owes it to its residents and constituents to select a replacement that would be a credit to the Council going forward. It also owes it to its residents and constituents to avoid million dollar expenditures that would detract from the City's finances and fiscal flexibility.

Many voters clamored for change in 2020, but even more clamored for competence and stability. That is even more so the case today. After so much drama and turmoil over our last pick, the City is owed a safe selection in whom the Council and the citizenry can have confidence. I urge you to follow our recommendation and appoint Jill Hardy. Thank you.
