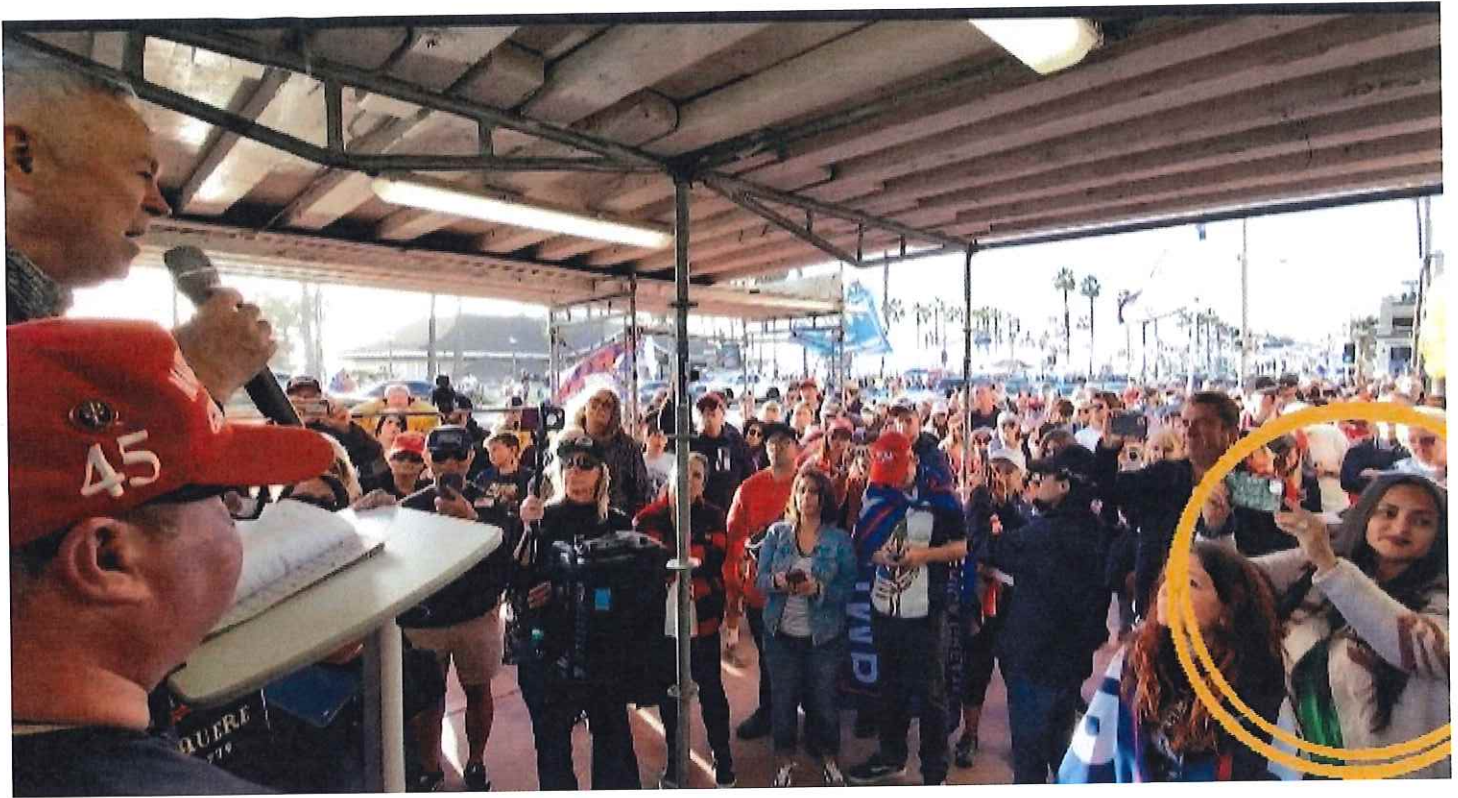

Good evening mayor and councilmembers. My name is Russell Neal and I live in Huntington Beach.

I would like to encourage the council to "respect the vote" and fill the vacancy created by Mr. Ortiz's resignation with the first runner-up from November's election, Gracey Van Der Mark, or failing that, by a special election.

My most recent service was 2 terms on the Personnel Commission about 4 years ago. I've applied for that commission again and my appointment is agendized for the June 15, 2021 City Council meeting.
