Dear City Council,

First I would like to thank our mayor, Kim Carr, for representing our beautiful city and keeping us informed when others would not.

"Normal" offshore drilling operations release toxic pollution into the air and water affecting our day-to-day living. All told, the oil drilling industry is responsible for 38% of all methane emissions (21 times more potent than carbon dioxide) in the United States.

One "minor" spill takes a substantial toll on our marine life and ecosystem and results in a loss of fishing and tourism revenue. Millions flock to Huntington Beach annually to enjoy our 10 miles of uninterrupted coastline, needless to say, we rely heavily on tourism. Protecting the environment has benefits beyond protecting our sea life and ecosystem.
