- Zone 2 Residential Overlay: Bid/Award Phase, Overlay is out to bid, ancillary infrastructure work is currently underway
- Arterial Rehabilitation 21/22: Construction Phase, Work continues on Hamilton and Warner Avenues

ADMINISTRATIVE ITEMS

23-381 FY 2022/23 Sewer Lining Project, CC-1728

John Dettle, Associate Civil Engineer, presented FY 2022/23 Sewer Lining Project, CC-1728, including scope of work, location information and cost estimate. Commissioner Frousiakis had questions regarding root intrusion; John explained the way sewers are designed and the areas susceptible to root intrusion. Commissioner Villa had questions regarding funding source; John explained the project is funded via sewer funds. Commissioner Shepherd had questions regarding City sewer and private property sewer maintenance jurisdictions; Mark Birchfield, Waste Water Supervisor, outlined where City responsibility begins and where private property owner responsibility begins.

Motion by Gins and second by Villa, the Commission voted to approve that the FY 2022/23 Sewer Lining Project, CC-1728 is in general conformance with the previously approved CIP.

Commissioner Villa had questions regarding the Engineer's Estimate, contingencies and inflation; John explained the cost breakdown and the anticipated impacts of inflation.

John Martin, Capital Projects Administrator, presented Construction of the Police Department (PD) Communications Center Renovation Project, CC-1677, including scope of work, location information and cost estimate. Commissioner Villa had questions regarding the number of workstations identified on the plans in relation to departmental needs; John explained that eleven workstations are in the plans and infrastructure will be built for an additional three workstations to accommodate anticipated departmental needs.

Sarah Whitecotton, Management Aide, presented the Infrastructure Fund Annual Report for Fiscal Year 2021/22. Commissioner Villa had questions regarding the revenue sources; Sarah explained primarily General Fund transfers, with a few smaller reimbursements, bonds and interest/market adjustments. Commissioner Gins had questions regarding the expenditures; Sarah and Ken Dills, Administrative Services Manager, explained primarily Capital Improvement Projects, as well as maintenance, operations, salaries.

Motion by Villa and second by Gins, the Commission voted to recommend to City Council approval of the Infrastructure Fund Annual Report for Fiscal Year 2021/22.

23-424 Fiscal Year 2022-23 Half Round Grate Project, CC-1733

Rafael Suarez, Capital Projects Administrator, presented Fiscal Year 2022-23 Half Round Grate Project, CC-1733, including scope of work, location information and cost estimate. Commissioner Villa had questions regarding completion of updates to all 384 half round grates; Rafael explained funding for half round grates varies annually, 70 have already been done, 50 are proposed with this project. Tom advised that due to funding constraints, no additional half round grates are proposed for next fiscal year's Capital Improvement Program. Commissioner Gins had questions regarding locations of half round grates throughout the City; Rafael explained they are primarily in the downtown area.

Motion by Gins and second by Macdonald, the Commission voted to recommend to City Council approval of the Infrastructure Fund Annual Report for Fiscal Year 2021/22.

MEMBER COMMENTS

Commissioner Frousiakis commented residents have reported changes to the Graffiti Abatement program and response times. Gretchen Erickson, Senior Administrative Assistant, advised there are no changes to the Graffiti Abatement program. Citizens can report graffiti via the MyHB App and by calling or visiting the Public Works Department. She explained Department data indicates response times for removal averages 1-2 business days. She noted graffiti not visible from the public right of way, graffiti belonging to other agencies and recent changes to HBMC 1.18.025 eliminating anonymous reporting in certain zones may lead to delayed response times. Commissioner Shepherd praised the Public Works Department and the MyHB app, indicating that when he reports an issue it is resolved quickly.
