PROJECT REVIEW (FUTURE AGENDA ITEMS)

18-281 GENERAL PLAN AMENDMENT NO. 16-001, ZONING MAP AMENDMENT NO. 16-002, TENTATIVE TRACT MAP NO. 18147, CONDITIONAL USE PERMIT NO. 16-031, MITIGATED NEGATIVE DECLARATION NO. 16-002 (SEA DANCE RESIDENTIAL DEVELOPMENT - Continued from July 10, 2018): To introduce revisions for the proposed land use and zoning map amendments from Public and Public-Semipublic to Residential Low Density and Open Space Park; a proposed subdivision for 51 new single family residences in a Planned Unit Development design with reduced lot sizes and public benefits for the community; and an analysis of the potential environmental impacts of the proposed project located at the former Franklin School site at 14422 Hammon Lane.

Jessica Bui, Associate Planner, gave a presentation and overview of the proposed project.

There was discussion on the following items: park maintenance, landscaping, public benefits, park ownership, street width, park in-lieu fees, the current pedestrian pathway, proposed parking, and the proposed house designs.
