Councilmember Carr recommended a discount on permit fees for seniors, and confirmed with Chief Handy that currently the appeal fee is zero until the issue is resolved.

Mayor Pro Tem Semeta stated her support for this program, and especially the education focus.

Mayor Peterson and Chief Handy discussed that both the alarm installation and alarm monitoring companies are required to report.
