<u>DIRECTOR ITEMS</u> – Chief Financial Officer Gilbert Garcia reviewed the Finance Commission Handbook, AR 102 and the Role of the Finance Commission. Garcia stated that Ordinance No. 4156 would be sent to the Finance Commission following the meeting.

Garcia stated that Chief Assistant City Attorney Michael Vigliotta would give Brown Act training at the next Finance Commission meeting.

The Finance Commission formally acknowledged the rescission of its March 27, 2019 motion to request that the City Council issue an RFP to contract out the functions of the Information Services Department.

Garcia stated that changes to Master Fee and Charges Schedule, including the EMS fees, would be presented to the Finance Commission in May or June, and to the City Council the following month.
