**22-413 Presentation: The History of Hate Crime Cases in Huntington Beach:
Examining the Murder of Vernon Fluornoy (Part 2)**

Franz says he remembers Dylan and Rusty stating they "got in a fight with a nigger." Wofford does a second interview. He admits he lied. They recovered the gun from the bush, the bullets from the toilet and the clothing.

They interviewed Kennedy to determine bail and he admits he is a white supremacist. Wofford had lots of past violence including burglaries. They then found proof of hate tied to him in the past. They find past burglaries in Kennedy's history as well and things tying him to hate. They tied the past attempted murder from Amberleaf to Kennedy as it was proven it was from the same handgun. Tattoos also became important evidence.

The later found a sketch and poem after Kennedy admitted that he beat up a Jewish man in jail. They both plead guilty. Kennedy was found guilty with hate crime enhancement and was also found guilty for Amberleaf attempted murder and received 19 years to life. He went to the superior court in Santa Ana to try to get his sentence changed and it was denied. Wofford is deceased. He was killed in a prison fight.
