**Adopt Resolution Nos. 2018-44 and 2018-45 calling for and consolidating with the County of Orange to conduct the General Municipal Election for City Officers (four Members of the City Council and a City Attorney) to be held on Tuesday, November 6, 2018**

**Statement of Issue:**

Resolutions must be adopted at the same City Council meeting to call for and consolidate with the County of Orange to conduct the November 6, 2018, General Municipal Election (election of four members of the City Council, and a City Attorney).

**Financial Impact:**

Funds estimated at \$110,000 have been budgeted in FY 2018/2019 Election Account No. 10010201.69505. Staff to return to Council if actual election costs exceed the budgeted amount.

**Recommended Action:**

A) Adopt Resolution No. 2018-44, "A Resolution of the City Council of the City of Huntington Beach, California, Calling for the Holding of a General Municipal Election to be held on Tuesday, November 6, 2018, for the Election of Certain Officers as Required by the Provisions of the City Charter;" and,

B) Adopt Resolution No. 2018-45, "A Resolution of the City Council of the City of Huntington Beach, California, Requesting the Board of Supervisors of the County of Orange to Consolidate a General Municipal Election to be held on Tuesday, November 6, 2018, with the Statewide General Election to be held on that date Pursuant to Section 10403 of the Elections Code."

**Analysis:**

The attached resolutions are needed in order to conduct the General Municipal Election, consolidated with the County of Orange, every two years.

The City Charter provides for City elections to be held pursuant to the State Elections Code. The attached resolutions comply with City Charter and State Code, and must be adopted to implement the November 6, 2018, election of four members of the City Council, and a City Attorney.
