Statement of Issue:

Resolution No. 2018-80 will recite the facts of the General Municipal Election held in Huntington Beach on the 6th day of November, 2018, declaring the results thereof and such other matters as provided by provisions of the City Charter and the Elections Code of the State of California.

Financial Impact:

Funds estimated at \$110,000 for the costs of the election were budgeted in FY 2018/19, Elections Account, Business Unit No. 10020101.69300 - Professional Services.
